#### 6.1 Anglican Communion

Synod notes the establishment of the Archbishop of Canterbury's Panel of Reference and encourages the Archbishop of Canterbury in making arrangements to protect and support parishes seeking alternative Episcopal oversight over matters of significance where there is repudiation of Biblical authority.

#### 6.2 Administration of confirmation by presbyters

Synod -

- (a) endorses the proposal that confirmation should not be required of those baptised as adults, before their being admitted to holy communion,
- (b) endorses the proposal that clergy, under licence from the Archbishop, be allowed to administer confirmation,
- (c) encourages the involvement of senior laypersons in the catechetical preparation of candidates for confirmation,
- (d) endorses the proposal that clergy, under licence from the Archbishop, be allowed to receive into the fellowship of the Anglican Church people who are communicant members of other Christian denominations, and
- (e) requests that the Standing Committee bring an ordinance to a forthcoming session of Synod or promote a General Synod Canon for the next General Synod that would make the above proposals possible.

### 6.10 Safe Ministry Policy

Synod -

(a) again requests that each parish council and diocesan organisation specifically adopt the following Safe Ministry Policy -

"The [name of Parish or organization] is committed to the physical, emotional and spiritual welfare and safety of all people, particularly within its own community. To ensure the safety of children and vulnerable people in our communities, the Church will -

- Carefully recruit and train its clergy and church workers,
- Adopt and encourage safe ministry practices by its clergy and church workers,

- Respond promptly to each concern raised about the behaviour of its clergy and church workers,
- Offer pastoral support to any person who has suffered abuse, and
- Provide supervision of and pastoral accountability to any person known to have abused a child or another vulnerable person"
- (b) requests that each non-parish organisation appoint at least one safe ministry representative equivalent to the parish safe ministry representative or a committee, if required, to take responsibility under the CEO to implement safe ministry policies in their organisation.

#### 6.11 Anglican - Roman Catholic International Commission

Synod notes the release by the Anglican – Roman Catholic International Commission (ARCIC) of *Mary: Grace and Hope in Christ* (The Seattle Statement) on 16 May 2005 and notes that many of the conclusions of the report are in conflict with the teaching of Scripture. We therefore distance ourselves from the report and further state that the Commission does not represent or speak on behalf of the Diocese of Sydney.

#### 6.12 Communion with the Church of England in England

Synod, while supporting the adoption of the General Synod canon to substitute a new section 6 in the Constitution of The Anglican Church of Australia –

- (a) notes, with regret, that the recent developments within the Church of England in England relating to same sex relationships may make it desirable that the existing section 6 of the Constitution (if it remains unchanged) and the proposed section 6(1) (if it is substituted for the existing section 6) be modified to make continued communion with the Church of England in England subject to the operation of canon of the General Synod, and
- (b) requests that the Standing Committee address this matter.

#### 6.13 Ministry brochure and use of the word "presbyter"

Synod -

- (a) notes the publication by Anglican Media Sydney in August 2005 of the brochure "Full-Time Paid Ministry in the Diocese of Sydney" and commends the authors for their helpful discussion of ministry and ordination in this Diocese.
- (b) commends the authors for their use throughout the brochure of the term "Presbyter" for the second order of ministry.
- (c) encourages the use of this brochure in recruiting suitable persons into the ministry of the Word in Diocese.
- (d) requests the Standing Committee to pursue the request of Synod (35/04) to produce a report of the practicality of replacing the word "priest" with words such as "presbyter" in all our legislation and formularies or at least to consider the legality of using such term in future ordination services and legislation.

#### 6.14 Funding chaplaincies

Synod, noting that money to support chaplaincies is not allocated in the Synod Appropriations and Allocations Ordinance 2005 -

- (a) affirms that Anglicare chaplaincies are integral to Policy 2 of the Diocesan Mission, specifically in their ability "to take further initiatives to create fellowships by penetrating structures of society beyond the reach of the parish church with the gospel", and
- (b) encourages Anglicare to seek alternative sources of funding for chaplaincies, and
- (c) requests the Standing Committee to
  - (i) urgently consider the immediate need for funding Anglicare chaplains and the practical steps necessary for the Diocese to do so, and
  - (ii) explore strategies which strengthen the contribution that chaplaincies make to the Diocesan Mission, and
  - (iii) report back to the next ordinary session of this Synod, and
  - (iv) in preparation for the 2007 session of Synod, when the principles of the Synod Appropriations and Allocations Ordinance are determined for the following triennium ensure as a priority that Anglicare chaplains are funded from the Diocesan budget.

#### 6.15 Anglicare chaplaincies

Synod requests that the Standing Committee ensure that a full and frank policy debate regarding Anglicare chaplaincies is scheduled for the next session of Synod. The debate ought to include the role and significance of the chaplains in the light of the Mission and give direction regarding future funding.
