- (a) requests each diocesan organisation to review the Governance Standards and Policy Guidelines in the Governance Policy and to take appropriate action to achieve conformity with the Governance Standards and, where appropriate, the Policy Guidelines, including through the promotion of amendments to the ordinance by which the diocesan organisation is constituted or otherwise regulated by the Synod,
- (b) requests the Standing Committee to prepare a long-term schedule of the ordinances by which diocesan organisations are constituted or otherwise regulated by the Synod in order to undertake a full consultation process with the board of each organisations about amendments that should be made to such ordinances to achieve conformity with the Policy, and
- (c) authorises the Standing Committee to make amendments to the Governance Policy provided such amendments are reported to the next ordinary session of the Synod."

- (d) requests the Secretariat, in light of this information, to consider and report to the Standing Committee on further steps that might be taken to achieve the goal of a paperless Synod, and
- (e) requests the Standing Committee, when choosing a venue for sessions of the 52nd Synod, to take into account the capacity of the venue to support Synod members accessing and downloading Synod documents by Wi-Fi during these sessions.'

- parties present (although this is preferable) but ENC must consider any feedback given.
- (c) All parties should encourage and maintain communication and a spirit of partnership in relation to their ministry activities.
