

Accounts, Audits and Annual Reports Ordinance 1995 Amendment Ordinance 2020

No 13, 2020

Long Title

An Ordinance to amend the *Accounts, Audits and Annual Reports Ordinance 1995*.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name of ordinance

This Ordinance is the Accounts, Audits and Annual Reports Ordinance 1995 Amendment Ordinance 2020.

2. Amendment

The *Accounts, Audits and Annual Reports Ordinance 1995* is amended as follows –

- (a) delete all the matter in clause 1(a), and insert instead the following –
‘Organisations that have been declared by the Standing Committee under this Ordinance as Category 1, Category 2 or Category 3 Organisations and;’
- (b) delete the matter ‘Each Organisation referred to in the Second or Third Schedule must’ in clause 7, and insert instead the matter ‘Each Category 2 and Category 3 Organisation must’,
- (c) insert a new clause 8A as follows –
‘8A. Standing Committee to declare categories for Organisations
 - (1) The Standing Committee may declare from time to time by resolution that an Organisation is a Category 1 Organisation, a Category 2 Organisation or a Category 3 Organisation for the purposes of this Ordinance.
 - (2) The Diocesan Secretary is to maintain and publish a register which records the categorisation of Organisations pursuant to declarations made under this clause.’,
- (d) delete the matter ‘Each Organisation referred to in the First Schedule’ in clause 9(1), and insert instead the matter ‘Each Category 1 Organisation’,
- (e) delete the matter ‘Each Organisation referred to in the Second or Third Schedule’ in clause 9(2), and insert instead the matter ‘Each Category 2 and Category 3 Organisation’,
- (f) delete the matter ‘A Organisation referred to in the Second Schedule’ in clause 10(2), and insert instead the matter ‘A Category 2 Organisation’,
- (g) clause 13 is amended as follows –
 - (i) delete the matter ‘Third Schedule’ in the title to clause 13, and insert instead the matter ‘Category 3’, and
 - (ii) delete the words ‘each Organisation referred to in the Third Schedule’ and insert instead the matter ‘each Category 3 Organisation’,
- (h) delete the First Schedule,
- (i) delete the Second Schedule, and
- (j) delete the Third Schedule.

3. Amendment to the *Anglican Church Growth Corporation Ordinance 2018*

The *Anglican Church Growth Corporation Ordinance 2018* is amended by omitting the matter in clause 21 and inserting instead –

‘The Corporation is to comply with the *Accounts, Audits and Annual Reports Ordinance 1995*.’

4. Amendment to the *Anglican Church Diocese of Sydney Community Building Partnership Grant Fund Ordinance 2012*

The *Anglican Church Diocese of Sydney Community Building Partnership Grant Fund Ordinance 2012* is amended by inserting a new clause 7A as follows –

Accounts, Audits and Annual Reports Ordinance 1995 Amendment Ordinance 2020

'7A. The Property Trust, as trustee of the Anglican Church Diocese of Sydney Community Building Partnership Grant Fund, is to comply with the *Accounts, Audits and Annual Reports Ordinance 1995*.'

5. Amendment to the *Mission Property Ordinance 2002*

The *Mission Property Ordinance 2002* is amended by omitting the matter in clause 13 and inserting instead –

'The Property Trust, as trustee of the Mission Property Fund, is to comply with the *Accounts, Audits and Annual Reports Ordinance 1995*.'

6. Amendment to the *Long Term Pooling Fund Ordinance 2012*

The *Long Term Pooling Fund Ordinance 2012* is amended by omitting the matter in clause 9 and inserting instead –

'The Property Trust, as trustee of the LTPF, is to comply with the *Accounts, Audits and Annual Reports Ordinance 1995*.'

7. Amendment to the *Diocesan Cash Investment Fund Ordinance 2016*

The *Diocesan Cash Investment Fund Ordinance 2016* is amended by omitting the matter in clause 10 and inserting instead –

'The Glebe Administration Board, as trustee of the Fund, is to comply with the *Accounts, Audits and Annual Reports Ordinance 1995*.'

8. Amendment to the *Sydney Anglican (National Redress Scheme) Corporation Ordinance 2018*

The *Sydney Anglican (National Redress Scheme) Corporation Ordinance 2018* is amended by omitting from clause 26 the words 'as if it was listed in Schedule 3 of that Ordinance,'.
