AN ORDINANCE to supplement "An Ordinance to appoint a person for the purposes of the 26th Section of the Constitutions and the 39th Section of the Church of England Trust Property Act 1917" (Assented to 25th November, 1921) and to amend the Administrator Ordinance No. 31 of 1963.

WHEREAS by or under "An Ordinance to appoint a person for the purpose of the 20th Section of the Constitution and the 39th Section of the Church of England Trust Property Act 1917" provision is made for the election of a person for the purposes therein mentioned AND WHEREAS the Right Rev. 2. Clause 2 of the said Ordinance is hereby amended by omitting the names of the Right Rev. R. C. Kerle and the Right Rev. M. L. Loane where occurring and inserting in lieu thereof the names of the Right Rev. M. L. Loane and the Right Rev. F. O. Hulme-Moir respectively.

3. This Ordinance may be cited as "The Administrator Ordinance 1963 Amending Ordinance 1965."
