

Amendment of Constitutions.

4/1895

AN ORDINANCE for accepting and adopting a certain Ordinance passed by the Provincial Synod Session 1895 intituled "An Ordinance to provide for making application to Parliament to pass an Act to repeal the Act 30 Victoria assented to 4th October 1866 and to substitute other provisions in lieu thereof."

(Assented to 2 October, 1895.)

WHEREAS a certain Ordinance was made by The Provincial Synod of the Province of New South Wales on the 20th day of July 1895 intituled "An Ordinance to provide for making application to Parliament to pass an Act to repeal the Act 30 Victoria assented to 4th October 1866 and to substitute other provisions in lieu thereof" a copy of which together with the Schedule thereto attached is contained in the Schedule attached to this Ordinance. And whereas it is expedient that the said Ordinance shall be accepted by the Church in this Diocese. The Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the United Church of England and Ireland within the Colony of New South Wales ordains and rules as follows:—

That the said Ordinance together with the Schedule attached thereto shall be and the same are hereby accepted and adopted and shall so far as the same are applicable be applied to the management of the Church in this Diocese in like manner as if the said Ordinance and the said Schedule attached thereto had been ordained and ruled by the Synod of this Diocese.

SCHEDULE.

AN ORDINANCE to provide for making application to Parliament to pass an Act to repeal the Act 30 Victoria assented to 4th October 1866 and to substitute other provisions in lieu thereof.

WHEREAS it is necessary to make provision for the several matters hereinafter mentioned, the Provincial Synod of the Province of New South Wales ordains and rules as follows:—

Application to Parliament.

1. Application shall be made to Parliament to pass an Act to repeal the Act 30 Victoria, assented to 4th October 1866 but without prejudice to anything done under the said Act before the repeal thereof and to authorise the substitution in all Statutes Acts Grants Deeds and other Instruments of the name "Church of England" for the name hitherto used of "United Church of England and Ireland" and to give legal force and effect to the Constitutions contained in the Schedule to this Ordinance.

Executive Committee to apply.

2. The Executive Committee of this Synod is hereby authorised and empowered to carry into effect the provisions of this Ordinance, and for this purpose to incur such expense as may be necessary so soon as and not before the Metropolitan shall have reported to them that every Diocese in the Province has either accepted this Ordinance or has duly referred the matters herein contained in this Synod.

Short Title.

3. This Ordinance may be cited as "The Amendment of Constitutions Application Ordinance of 1895."
