

# Anglican Church Growth Corporation and Mission Property Amendment Ordinance 2021 Amendment Ordinance 2022

No 1, 2022

## Long Title

An Ordinance to amend the *Anglican Church Growth Corporation and Mission Property Amendment Ordinance 2021*.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

### 1. Name of ordinance

This Ordinance is the Anglican Church Growth Corporation and Mission Property Amendment Ordinance 2021 Amendment Ordinance 2022.

### 2. Amendment

The *Anglican Church Growth Corporation and Mission Property Amendment Ordinance 2021* is amended as follows –

- (a) in subclause 2(c) delete the matter '5(1)(a)' and insert instead the matter '5(1)(b)',
- (b) in subclause 2(f) delete the matter 'elected as a member by the Standing Committee' and insert instead the matter 'appointed by the Archbishop',
- (c) in subclause 3(l) substitute the proposed paragraph 8(1)(d) with the following –
  - “(2) grant or facilitate security over all or part of –
    - (i) the Specified Property, and
    - (ii) where authorised by Ordinance -
      - (A) any property held on a trust for the purposes of the Diocese, and
      - (B) any property held on trust for the purposes of a parish,for the financial obligations of any person or corporation in connection with an acquisition, subdivision, development, construction or renovation referred to in paragraphs (a), (b) and (c), or”
- (d) in the table in subclause 4(1) –
  - (i) delete each instance of the matter “5(1)(a)” and insert instead the matter “5(1)(b)”, and
  - (ii) delete the matter “5(1)(b)” and insert instead the matter “5(1)(c)”,
- (e) insert a new subclause 5(2) as follows (and renumber the existing subclause 5(2) as subclause 5(3) –
  - “(2) The following provisions commence on the date of assent of the Anglican Church Growth Corporation and Mission Property Amendment Ordinance 2021 Amendment Ordinance 2022 –
    - (a) subclauses 2(a)(ii), 2(b) to 2(h), 2(n), 2(p) and 2(q), and
    - (b) clause 4.
