ANGLICAN COUNSELLING CENTRE CONSTITUTION AMENDMENT ORDINANCE 1987

AN ORDINANCE to amend the Anglican Counselling Centre Constitution Ordinance 1963.

WHEREAS certain church trust property is held pursuant to the Anglican Church Trust Property Act 1917 upon trust for the Anglican Counselling Centre, an organisation whose objects and constitution are set forth and contained in the Anglican Counselling Centre Constitution Ordinance 1963 (herein called the "Principal Ordinance") and WHEREAS it is expedient to amend the Principal Ordinance.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows.

1. This Ordinance may be cited as the "Anglican Counselling Centre Constitution Amendment Ordinance 1987".

- 2. Clause 7 of the Principal Ordinance is amended :-
 - (a) by omitting "Six" and by inserting instead "Seven" in paragraph (iii) thereof;
 - (b) by adding the following new paragraph (iv) immediately after paragraph (iii) namely -
 - "(iv) Two clergymen who shall be licensed to parishes, provisional parishes, or new housing districts within the Diocese, elected by the Synod";
 - (c) by renumbering paragraphs (iv) and (v) as numbers (v) and (vi) respectively;
 - (d) by adding immediately after "elected members" where first appearing the following words: "(who shall include collectively those persons mentioned in paragraphs (iii) and (iv) hereof as one class)";
 - (e) by omitting the words -

"hold office until the ordinary session of Synod held in 1964 and thereafter at the ordinary session of Synod in each year one third shall retire"

and by inserting the following words -

"retire at the ordinary session of Synod in each year"; and

(f) by omitting the words -

"The first elected members shall be the following:-The Right Rev R.C. Kerle Dr N.D. Campbell The Rev. A.H. Funnell Mr B.R. Davies The Rev A.W. Setchell Mr W.L.J. Hutchison"

3. Clause 10 of the Principal Ordinance is amended:-

- (a) by omitting "at its first meeting after this Ordinance comes into force and thereafter"; and
- (b) by omitting "financial".
- 4. Clauses 11 and 12 of the Principal Ordinance are omitted.
- 5. The Principal Ordinance is further amended:-
 - (a) by omitting the matter "-1978" from clause 16; and
 - (b) by omitting the matter "-1983" from clause 17.

I CERTIFY that the Ordinance as printed is in accordance with the Ordinance as reported.
