## ANGLICAN PROVIDENT (SYDNEY) ORDINANCE AMENDING ORDINANCE 1987

## No. 29, 1987

An ORDINANCE to further amend the Anglican Provident Fund (Sydney) Ordinance 1944-1986.

WHEREAS it is desirable that the Anglican Provident Fund (Sydney) Ordinance 1944-1986 be further amended to facilitate the administration of the fund thereby governed and to confer further advantages on certain of the members thereof.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

- 1. (1) This Ordinance may be cited as "Anglican Provident Fund (Sydney) Ordinance Amending Ordinance 1987".
- (2) The Anglican Provident Fund (Sydney) Ordinance 1944-1986 is hereinafter called the "Principal Ordinance".
- (3) The Principal Ordinance as amended by this Ordinance may be cited as "Anglican Provident Fund (Sydney) Ordinance 1944-1986" and Clause 1(1) of the Principal Ordinance is amended accordingly.
- 2. The Principal Ordinance is amended as follows:
  - by the omission of the words "without interest" from clause 43B(1);
  - (2) by the insertion of the following at the end of clause 43B(1): "In addition, the Board may pay to the member such further sum which, in the opinion of the Board, after consulting with the Actuary, is fair and reasonable in the circumstances";
  - (3) by the omission of "one-half of" in clause 4(1) of the Sixth Schedule;
  - (4) by the insertion of the following after the first sentence of clause 4(1) of the Sixth Schedule and at the end of the clause 4(2) of the Sixth Schedule: "In addition, the Board may pay to the member such further sum which, in the opinion of the Board, after consulting with the Actuary, is fair and reasonable in the circumstances";
  - (5) by the substitution of "f" for "e" in the sentence which immediately follows paragraph (f) of clause 9(2) of the Seventh Schedule;
  - (6) by the substitution of the "account" for "amounts" in paragraph (h) of clause 9(2) of the Seventh Schedule.

I CERTIFY that the Ordinance as printed is in accordance with the Ordinance as reported.
