# The Archbishop of Sydney's Anglican Aid Incorporation and Transition Ordinance 2011

No 48, 2011

## Long Title

An Ordinance to enable the constitution of the members of The Archbishop of Sydney's Anglican Aid as a body corporate pursuant to the provisions of the Anglican Church of Australia (Bodies Corporate) Act 1938.

#### Preamble

A. By The Archbishop of Sydney's Anglican Aid Ordinance 2011 (the "Constituting Ordinance") the Standing Committee of the Synod of the Diocese of Sydney constituted The Archbishop of Sydney's Anglican Aid to further the work of the Anglican Church of Australia within the Diocese of Sydney by proclaiming the love of God as shown in Christ in promoting and conducting activities of a social welfare, pastoral and charitable nature, to be executed by charitable and humanitarian work for the relief of poverty, sickness, suffering, distress, misfortune and helplessness.

B. It is expedient for the purpose of managing, governing or controlling the said body that the persons who are members of the said body should be constituted as a body corporate pursuant to the Anglican Church of Australia (Bodies Corporate) Act 1938.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

#### 1. Name

This Ordinance is The Archbishop of Sydney's Anglican Aid Incorporation and Transition Ordinance 2011.

#### 2. Declarations

It is expedient for the purpose of managing, governing or controlling the institution or organisation known as The Archbishop of Sydney's Anglican Aid (being an institution or organisation of the Anglican Church of Australia) that the persons who for the time being are the members of "The Archbishop of Sydney's Anglican Aid" should be constituted a body corporate under that name.

## 3. Transition

(1) For the purposes of clause 9(1)(a) of the Constituting Ordinance Bishop Peter Tasker and Dr Philip Selden are taken to have been appointed on the date assent is given to the Constituting Ordinance.

(2) For the purposes of clause 9(1)(b) of the Constituting Ordinance the following persons are taken to have been elected or appointed on the date assent is given to the Constituting Ordinance –

Mr David Dennis, Mr Ross Hall, Dr Jim Langridge, Mrs Patricia Spencer, and Mrs Wendy Toulmin.

(3) The Rev David Mansfield is taken to have been appointed as Executive Director by Anglican Aid for the purposes of clause 19 of the Constituting Ordinance.

## 4. Commencement

This Ordinance commences on the later of the date assent is given to this Ordinance and the date assent is given to the Constituting Ordinance.
