
*Arden Church of England Girls' School Variation of
Trusts Ordinance 1964*

No. 32, 1964.

AN ORDINANCE to vary the trusts upon which certain land and premises in Railway Parade, Beecroft in the Shire of Hornsby are held and to declare the trusts upon which the same shall be held.

WHEREAS Church of England Property Trust Diocese of Sydney (hereinafter called the Corporate Trustee) is registered as proprietor of an estate in fee simple of the land comprised in Certificate of Title Volume 6204 Folio 12 more particularly described in the Schedule hereto (hereinafter called "the said land") for the use, benefit and purposes of the Council for the Promotion of Sydney Church of England Diocesan Schools and of the schools controlled managed and carried on by the said Council or any of them AND WHEREAS the said land was purchased for the purpose of carrying on, managing and controlling by the said Council of a school known as Arden Church of England Girls' School (hereinafter called the "School") AND WHEREAS the said land has been mortgaged in pursuance of The Council for the Promotion of Sydney Church of England Diocesan Schools Mortgage Ordinance, 1951 (No. 23 of 1951) AND WHEREAS in pursuance of the Arden Church of England Girls' School Ordinance 1962 (No. 15 of 1962) the Arden Church of England Girls' School Council is now carrying on, managing, governing and controlling the School on the said land AND WHEREAS by reason of circumstances which have arisen subsequent to the creation of the trusts on which the said land is held it is inexpedient to carry out and observe the same and it is expedient that such trusts be modified or varied as hereinafter set out NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of such Synod HEREBY DECLARES ORDAINS AND DIRECTS as follows:-

1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the said land is held it is inexpedient to carry out and observe the same and it is expedient that such trusts be modified and varied as hereinafter set out.

2. The said land shall subject to the mortgage hereinbefore mentioned henceforth be held by the Corporate Trustee upon trust to permit the same to be used for the use benefit and purposes of the School at Beecroft in connection with the Church of England in Australia in the Diocese of Sydney.

3. This Ordinance may be cited as "Arden Church of England School Variation of Trusts Ordinance, 1964."

THE SCHEDULE

The whole of the land comprised in Certificate of Title Registered Volume 6204 Folio 12 situated in Railway Parade, Beecroft in the Shire of Hornsby where is erected certain premises known as No. 69 Railway Parade, Beecroft.
