Deanery Ordinance 1985

No. 1985

An anninance to change the terminology used in certain ordinances and to enable other documents to be interpreted.

A. By resolution 22/64, the Synod respectfully requested the Archbishop to favourably consider renaming "Rural Deanerles" as "Area Deanerles".

B. Rural Deanerles are established and Rural Deans are appointed under regulations first made by the Archbishop in 1871 after taking advice from the Standing Committee.
