

*Bishop Coadjutor—Amendment.*

AN ORDINANCE for accepting and adopting a certain Determination of the General Synod, Session 1921, (No. IV.), intituled, "Determination Amending Rule 4 of Determination II., 1896."

WHEREAS a certain Determination being Determination No. IV., was made by the General Synod of the Dioceses in Australia and Tasmania on the tenth day of October, 1921, intituled "Determination amending Rule 4 of Determination II., 1896," a copy of which is contained in the Schedule annexed to this Ordinance. AND WHEREAS it is expedient that the said Determination shall be accepted by the Church in this Diocese. THE SYNOD OF THE DIOCESE OF SYDNEY in pursuance of the power's in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England within the State of New South Wales ordains and rules as follows:—

That the said Determination and the Rules therein contained, and each and every of them shall be, and the same are and is hereby accepted and adopted, and shall so far as the same are applicable be applied to the management and government of the Church in this Diocese in like manner as if the said Determination, and the Rules therein contained, and each and every of them had been ordained and ruled by the Synod of this Diocese.

DETERMINATION AMENDING RULE 4 OF  
DETERMINATION II., 1896.

Rule 4 of Determination II., 1896, is hereby repealed.

WHEREAS it is expedient to amend Determination II., General Synod, Session 1896, be it enacted by the Archbishops, Bishops, Clergy and Laity in General Synod as follows:—

Section 4 of the said Determination is hereby repealed and the following new Section shall take the place of the said repealed Section.

No such appointment or Consecration as aforesaid shall take place unless and until the majority of the Metropolitans are satisfied that a sufficient income is provided for such Bishop Coadjutor.
