BISHOP OF SYDNEY STIPEND ORDINANCE OF 1909.

(As passed.)

AN ORDINANCE to fix the amount of stipend to be paid to the Bishop of the Diocese of Sydney under the provisions of the "Sydney Diocesan Revenues Act of 1905."

WHEREAS by the "Sydney Diocesan Revenues Act of 1905" hereinater referred to as the said Act the Synod of the Diocese of Sydney was empowered to fix from time to time by Ordinance passed in the manner provided by the "Church of England Constitutions Act Amendment Act of 1902" or any Act amending or repealing the same the amount of stipend to be paid to the Bishop of the Diocese of Sydney. And whereas the office of Bishop of the said Diocese is now vacant and it is expedient to pass such Ordinance before the acceptance of office by the next Bishop of the said Diocese. The Synod of the Diocese of Sydney in pursuance of the provisions of the said Act and of the "Church of England Constitutions Act Amendment Act of 1902" and of all other powers vested in the said Synod ordains and rules as follows:—

- 1. The amount of the stipend to be paid to the Bishop of the Diocese of Sydney shall be at the rate of £2,250 per annum free of all rates and taxes mentioned and referred to in Sections 3 and 6 of the said Act, and of the cost of repairing renovating or improving the Episcopal residence for the time being of the said Bishop and of repairing or renewing fences appurtenant thereto, and such stipend shall be payable to the said Bishop during his occupancy of the said Sec.
- 2. This Ordinance may be cited as the "Bishop of Sydney Stipend Ordinance of 1909."

In compliance with request of the Venerable Ardudeacon Ginther, Administrator of the Diocese of Sydney, we have made careful investigation of the funds, securities and ripoetries, which represent the Endowment of the Bisnopric of Sydney, and now beg to submit the following report of the revenues of the Sec.

The Indowment consists of the undermeationed properties and the funds from the to time derived there for and otherwise invested.
