

Campbelltown Anglican Schools Ordinance 1985 Amendment Ordinance 2020

No 20, 2020

Long Title

An Ordinance to amend the *Campbelltown Anglican Schools Ordinance 1985*.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name of ordinance

This Ordinance is the Campbelltown Anglican Schools Ordinance 1985 Amendment Ordinance 2020.

2. Amendment

The *Campbelltown Anglican Schools Ordinance 1985* is amended as follows –

- (a) amend clause 5 as follows –
 - (i) insert the word ‘and’ at the end of clause 5(2)(a),
 - (ii) remove the matter ‘; and’ in clause 5(2)(b) and insert instead a full stop,
 - (iii) delete clause 5(2)(c) in its entirety,
 - (iv) insert a new clause 5(2A) as follows –

‘(2A) Every member must, upon being appointed or elected as, or otherwise becoming, a member, sign –

 - (a) the “Statement of Personal Faith” set out in the Schedule, and
 - (b) a statement that indicates that he or she is willing to promote the Objects of the Council

and deliver it to the Secretary within 28 days of the date of that person becoming a member. If a person fails to do so, the person is disqualified from being, and automatically ceases to be, a member.’, and
 - (v) delete the words ‘declaration referred to in clause 5(2)(c)’ in clause 5(3) and insert instead the words ‘statements referred to in clause 5(2A)’,
- (b) delete the words ‘the first’ in subclause 7(2), and insert instead the words ‘each ordinary’,
- (c) delete the reference to ‘clause 5(2)(c)’ in clause 9(j), and insert instead the reference ‘clause 5(2A)(a)’,
- (d) amend clause 22 as follows –
 - (i) remove the word ‘and’ at the end of clause 22(a),
 - (ii) remove the full stop in clause 22(b) and insert instead a comma, and
 - (iii) insert new clauses (c) – (e) as follows –
 - (c) the *Investment of Church Trust Property Ordinance 1990*,
 - (d) the *Sydney Anglican Use of Property Ordinance 2018*,
 - and
 - (e) the *Safe Ministry to Children Ordinance 2018*.’,
- (e) amend Schedule 1 as follows,
 - (i) delete the word ‘and’ at the end of paragraph 2(b),
 - (ii) delete the full stop at the end of paragraph 2(c) and insert instead a semi-colon,
 - (iii) insert a new paragraph 2(d) as follows –
 - (d) that this faith produces obedience in accordance with God’s word, including sexual faithfulness in marriage between a man and a woman, and abstinence in all other circumstances.’

3. Transitional

For the purposes of the amended subclause 7(2) of the *Campbelltown Anglican Schools Ordinance 1985* each of the following persons are taken to have been last elected as a member by the electing or appointing body as follows –
