The Castle Hill Glebe Sale Ordinance 1893 (Amendment) Ordinance 1955.

No. 28, 1955.

AN ORDINANCE to amend "The Castle Hill Glebe Sale Ordinance 1893"; to provide for the application of certain proceeds of sale; to vary the trusts thereof and for purposes incidental thereto.

WHEREAS by virtue of "The Castle Hill Glebe Sale Ordinance 1893" (herein referred to as the principal Ordinance) authority was granted for the sale of the land described in the Schedule thereto and it was directed that the proceeds of the sale should be applied first in the purchase of Lots 14 and 15 of Section 7 of Baulkham Hills Estate and secondly in the purchase of other lands situated in such Parish and that any balance of such proceeds not immediately required for the aforesaid purposes should be deposited in a bank for the purposes specified in the principal Ordinance AND WHEREAS part of the said land was sold and the proceeds wholly applied towards the purchase of the said Lots 14 and 15 AND WHEREAS the balance of the land described in the Schedule to the principal Ordinance has since been disposed of and the net proceeds amounting to One hundred and fifteen pounds (£115) are held by the Church of England Property Trust Diocese of Sydney (hereinafter called the Corporate Trustee) AND WHEREAS it is inexpedient to apply the said proceeds in manner set out in the Principal Ordinance and it is expedient to amend such Ordinance as hereinafter set out Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod hereby Ordains and Directs as follows:----

- (a) This Ordinance may be cited as "The Castle Hill Globe Sale Ordinance 1893 (Amendment) Ordinance 1955".
 - (b) "The Castle Hill Glebe Sale Ordinance 1893" is referred to in this Ordinance as "the Principal Ordinance".

2. The Principal Ordinance is amended by omitting Clause 4 and inserting the following clause in the place thereof:--- The Castle Hill Glebe Sale Ordinance 1893 (Amendment) Ordinance 1955.

4. The said proceeds arising from the said sale or sales shall be applied (after payment thereout of all proper expenses of and incidental to this Ordinance and the said sale or sales and the transfers of the said land in pursuance thereof) in the purchase of Lots fourteen and fifteen of Section seven of the Baulkham Hills Estate being other lands situate in the same Parish such land to be vested in the "Church of England Property Trust Diocese of Sydney" and to be held by the said Trust as a Glebe annexed to the Church of St. Paul at Castle Hill aforesaid and if there be more than sufficient for this purpose then the balance shall be paid to the Corporate Trustee and shall be held by the said Corporate Trustee to be applied in and towards the provision of septic sewerage for the Rectory and Church of St. Paul at Castle Hill and so far as not so used and applied for such other works of a capital nature upon Church property within the said Parish as the Standing Committee may by resolution determine.
