AN ORDINANCE to amend further "The Cathedral Compensation Fund (Organs) Ordinance 1948."

WHEREAS "The Cathedral Compensation Fund (Organs) Ordinance 1948" as amended authorised the application of an amount not exceeding Twenty thousand pounds (£20,000) out of the income of the Cathedral Compensation Fund referred to in the said Ordinance in and towards the repair alteration improvement and generally the putting in order of the two organs in the Cathedral Church of St. Andrew Sydney and in and towards doing all such other things as the Chapter shall deem necessary and the Standing Committee shall by resolution approve to combine and convert the said two organs into one organ to be played and operated from one console including the demolition in whole or in part of either or both of the said organs. AND WHEREAS by the St. Andrew's Church and School Property Trust Variation Ordinance 1949 provision is made for the repayment of the said Twenty thousand pounds (£20,000) (or such other sum as may have been expended pursuant to the said Cathedral Compensation Fund (Organs) Ordinances in the manner therein indicated.)

AND WHEREAS it is expedient to dismantle the "Whitely" Organ in the (true) North Transept and to rebuild it to clear the aisle.

AND WHEREAS the cost of carrying out this additional work and matters incidental thereto plus the usual escalator clause is estimated not to exceed £2,000 in all. Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod declares and ordains as follows:—

1. By reason of circumstances subsequent to the creation of the trusts of the income of the Cathedral Compensation Fund referred to in the said Cathedral Compensation Fund (Organs) Ordinance 1948 as amended it has become inexpedient to carry out or observe the trusts appertaining thereto to the extent to which the same are varied by this Ordinance and it is expedient that such trusts be varied accordingly.

2. An amount not exceeding Two thousand pounds (£2,000) out of the said income may be applied in or towards dismantling the "Whitely" Organ in the (true) North transept and rebuilding it to clear the aisle and matters incidental thereto.

3. The "St. Andrew's Church and School Property Trust Variation Ordinance 1949" is hereby amended—

by deleting from sub-clauses (a) and (b) of Clause 3 the figures Twenty thousand pounds (£20,000) (twice appearing) and inserting in lieu thereof the figures Twenty-two thousand pounds (£22,000).

4. This Ordinance may be cited as "The Cathedral Compensation Fund (Organs) Furthering Amendment Ordinance 1950."
