# **CENEF University Hall (Change of Name) Ordinance** 1994

No 32, 1994

### Long Title

An Ordinance to change the name of CENEF University Hall and CENEF University Hall Council.

#### **Preamble**

Whereas it is expedient to change the name of CENEF University Hall and CENEF University Hall Council.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod Hereby Ordains Declares Directs and Rules as follows.

## Citation

This ordinance may be cited as the "CENEF University Hall (Change of Name) Ordinance 1994".

#### **Amendments**

- 2. The CENEF University Hall Council Ordinance 1977 is amended as follows -
  - (a) clause 1 is deleted and the following is inserted instead -
    - "1. This ordinance may be cited as the 'Arundel House Council Ordinance 1977'.";
  - (b) paragraph (c) of clause 2 is deleted and the following is inserted instead -
    - "(c) 'Arundel House' means the said land and the improvements thereon;";
  - (c) clause 3 is deleted and the following is inserted instead -
    - 3. The name of the Council shall be 'Arundel House Council'."; and
  - (d) in paragraphs (a) and (c) of clause 4 the matter "CENEF University Hall" is deleted and the words "Arundel House" are inserted instead.
- 3. The CENEF University Hall Ordinance 1977 is amended as follows -
  - (a) clause 6 is deleted and the following is inserted instead -
    - "6. The Forest Lodge land shall be known as 'Arundel House'."; and
  - (b) clause 8 is deleted and the following is inserted instead -
    - "8. This ordinance may be cited as 'Arundel House Ordinance 1977'.".
- Subclause 3(3) of the CENEF Ordinance 1978 is amended by deleting the matter "CENEF University Hall Ordinance 1977" and by inserting instead the matter "Arundel House Ordinance 1977".
- 5. The CENEF University Hall Mortgage Ordinance 1986 is amended as follows -
  - (a) clause 2 is deleted and the following is inserted instead -
    - "2. The government, control and management of Arundel Street shall vest in the Arundel House Council and the provisions of the Arundel House Council Ordinance 1977 shall extend to Arundel Street.";
  - (b) in subclause 3(2), the matter "CENEF University Hall Council" is deleted and the words "Arundel House Council" are inserted instead; and
  - (c) subclause 3(4) is deleted and the following is inserted instead -
    - "(4) This ordinance may be cited as the 'Arundel House Mortgaging Ordinance 1988'.".
