
The Centennial Church Extension Fund 1922.

AN ORDINANCE declaring the Trusts of the Centennial Church Extension Fund and relieving the Church of England Property Trust Diocese of Sydney from inquiring or taking any action in respect of the past administration of the said Fund.

WHEREAS by the "Church Trust Property Governing and Controlling Ordinance 1921" certain Church Trust Property called and known as the Centennial Church Extension Fund was vested in the Church of England Property Trust Diocese of Sydney (hereinafter referred to as the "Corporate Trustees") AND WHEREAS the Trusts to which the same is subject are not sufficiently evidenced and it is desirable to declare the purpose for which the said Church Trust Property is held in Trust the Synod of the Diocese of Sydney in pursuance of the powers conferred upon it by the Constitutions for the management and good government of the Church of England within the State of New South Wales and by the "Church of England Trust Property Act 1917" and otherwise ordains declares and rules as follows:—

1. The purposes for which the said Fund is held in Trust by the said Trustees and subject to the said "Church Trust Property Governing and Controlling Ordinance" are hereby declared to be the extension of the Church's work as follows, nameily:—

(1) By Living Agents:—

- (a) In the provision of Clergy and Religious Instructors especially in new districts;
- (b) In the extension, when possible, of the Episcopate;
- (c) In the extension of Missionary Agency.

(2) By Material Machinery:—

- (d) In the grant or loan for Church building in struggling districts.

2. It is further declared that the following moneys are held in Trust for the purposes stated below:—

The sum of £1000 for each of the following Dioceses, namely, Goulburn and Bathurst, and the sum of £1500 for the Diocese of Riverina. The interest gained on the said several sums to be annually paid to the respective Dioceses,

And it is further declared that the sum of £50 given by the Parish of St. Paul's, Sydney, in the State aforesaid, is held in Trust for the Australian Board of Missions. The interest gained thereon to be annually paid to the said Board towards the New Guinea Mission.

And it is further declared that the sum of £50 is held in Trust towards the building of a Tower for the Church of Holy Trinity at Sydney aforesaid.

3. The Corporate Trustees are hereby relieved from the obligation, if any, of inquiring into or taking any action in respect of the past administration of the said Fund.

4. This Ordinance may be cited as "The Centennial Church Extension Fund Ordinance 1922."
