#### CHRIST CHURCH ST. IVES ORDINANCE 1978

# No. 40 1978

AN ORDINANCE to declare the trusts affecting certain property known as No. 19 Murchison Street St. Ives and to authorise the sale of land known as Lot 3 Walker Avenue, St. Ives.

WHEREAS Church of England Property Trust Diocese of Sydney (hereinafter called " the Corporate Trustee") is registered as proprietor in fee simple of the land known as Lot 3 Walker Avenue St. Ives and more particularly described in the First Schedule hereto (which said land is hereinafter called "the Walker Avenue land") AND WHEREAS the Corporate Trustee is also registered as proprietor in fee simple of the land and buildings known as No. 19 Murchison Street, St. Ives and more particularly described in the Second Schedule hereto (which said land and buildings are hereinafter referred to as "the Murchison Street property") AND WHEREAS the Walker Avenue land is church trust property held by the Corporate Trustee upon the trusts set forth in the Third Schedule hereto AND WHEREAS the Murchison Street property is also church trust property held by the Corporate Trustee but no trusts have been declared in writing concerning the same AND WHEREAS the Walker Avenue land is vacant land not required for any purposes in connection with the Parish of Christ Church, St. Ives and it is expedient that the subject land be sold and that the net sale proceeds be appropriated in the manner hereinafter provided AND WHEREAS it is expedient that the trusts presently relating to the Walker Avenue land be henceforth imposed upon the Murchison Street property NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

- 1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the Walker Avenue land is held it is inexpedient to carry out and observe the same and it is expedient that such land be sold and that the trusts be varied as hereinafter set forth.
- 2. The Corporate Trustee is hereby empowered to sell the Walker Avenue land in one or more parcels by public auction or by private contract at such time or times at such price or prices and upon and subject to such terms, conditions, covenants and reservations as it shall think fit freed from the trusts upon which

it is presently held PROVIDED THAT the Transferee of Transferees of the subject land for himself, herself or themselves, his, her or their successors, assigns or personal representatives and the registered proprietors for the time being of the land shall enter a restrictive covenant for the benefit of the adjoining land known as Lot 4 in Deposited Plan No. 232081 to the effect that the Transferee or Transferees and the registered proprietors for the time being of the Walker Avenue land shalf not sell or cause to be sold any intoxicating liquor thereon or on any part thereof and such covenant may be released, varied or modified only by the prior written consent of the Corporate Trustee and of the majority for the time being of the members of the Parish Council of the Parish of Christ Church, St. Ives or of any other parish into which such Parish shall be formed or divided. The proceeds arising from the sale of the Walker Avenue land after paying thereout all costs of and incidental to this Ordinance and to the sale and transfer in pursuance thereof and all outgoings to which the said land may be subject shall be applied in or towards the reduction or repayment of all moneys borrowed from the Bank of New South Wales for the purpose of or incidental to the acquisition and purchase of the Murchison Street property and any balance thereafter is to be applied in accordance with a resolution of the Parish Council of the said Parish approved by a resolution of the Standing Committee PROVIDED THAT such moneys shall be applied for the benefit of the parish of Christ Church St. Ives or any parish or district into which it may subsequently be formed.

4. The Murchison Street property shall henceforth be held upon trust to permit the same to be used for a residence for a minister or full time lay worker or parish hall or partly for one and partly for another of such purposes in connection with the Church of England in Australia in the said Parish of Christ Church, St. Ives or any parish or district into which such parish shall be formed or divided and to be subject to the provisions of the Sydney Church Ordinance 1912 or any other ordinance of the Diocese of Sydney for the time being in force and applicable to the said property PROVIDED HOWEVER that in the event of the Archbishop in council at any time hereafter determining in his or their absolute discretion that the said property can no longer be used for the purposes aforesaid or any one or more of them in the Parish of Christ Church, St. Ives or any parish into which such parish shall be formed or divided upon trust to permit the same to be used for and

by the Home Mission Society of the Church of England in the Diocese of Sydney for the general purposes thereof absolutely.

5. This Ordinance may be cited as Christ Church St. Ives Ordinance 1978.

#### FIRST SCHEDULE

ALL THAT land situate at St. Ives in the Municipality of Ku-ring-gai Parish of Gordon and County of Cumberland being Lot 3 in Deposited Plan No. 232081 having a frontage of about 83 ft. to Walker Avenue and being the whole of the land in Certificate of Title Volume 10552 Folio 187.

### SECOND SCHEDULE

<u>ALL THAT</u> land situate at St. Ives in the Municipality of Ku-ring-gai Parish of Gordon and County of Cumberland being Lot 12 in Deposited Plan No. 215973 having a frontage of about 57 ft. to Murchison Street and being the whole of the land in Certificate of Title Volume 9370 Folio 194 together with improvements thereon known as No. 19 Murchison Street, St. Ives.

## THIRD SCHEDULE

UPON TRUST to permit the same to be used for a church parsonage or parish hall or partly for one and partly for another of such purposes in connection with the Church of England in Australia in the Parish of Christ Church, St. Ives or any parish into which such parish shall be formed or divided and to be subject to the provisions of the Sydney Church Ordinance 1912 or any other Ordinance of the Diocese of Sydney for the time being in force and applicable to the said land PROVIDED HOWEVER that in the event of the Archbishop in council at any time hereafter determining in his or their absolute discretion that the said lands can no longer be used for the purposes aforesaid or any of them or more of them in the Parish of Christ Church, St. Ives or any parish into which such parish shall be formed or divided upon trust to permit the same to be used for and by the Home Mission Society of the Church of England in the Diocese of Sydney for the general purposes thereof absolutely.
