AN ORDINANCE to acquire the School known as "The Church of England Grammar School for Girls. Cremorne" and to regulate the Constitution of the Council of the said School and the management of its affairs and to provide for the course of instruc-... tion to be imparted therein and for other matters in connection with the order and discipline thereof.

WHEREAS on behalf of the Church of England the School "Church of England Grammar School for Girls Cremorne" (formerly known as "Arden College") situated at Cremorne in the State of New South Wales has been acquired by certain members of the Church of England as from the eleventh day of September One thousand nine hundred and nineteen from the Misses Haslingden by virtue of a certain Agreement dated the eleventh. day of September One thousand nine hundred and nineteen for a the purpose of establishing the said School as a Ladies' College governed by a Council under the auspices of the Church of England AND WHEREAS since the date of such acquisition the said Church of England Grammar School for Girls Cremorne has been under the government of a Council consisting of ten per sons with the Archbishop as Patron AND WHEREAS it is expedient to confirm and endorse the action of the said members and to adopt the said School and to make rules and regulations touching the constitution thereof and the appointment and nowers of the Council of the said School and the course of instruction to be imparted in the said School and all matters in connection with the order and discipline thereof Now THERE-FORE the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England within the State of New South Wales and of all powers vested in the said Synod by the "Church of England Trust Property Act 1917" ordain and rules as follows :-

<sup>1.</sup> The acquisition of the said School "The Church of England Grammar School for Chirls Cremorne" is hereby confirmed and adopted upon the terms and conditions set out in the said Agreement.

- 1912. The name of the said School shall be "The Church of England Grammar School for Girls Cremorbe."
- be known as "The Council of the Church of England Grammar School for Girls Cremorne."
- 4. The members of the Council shall be the Archbishop of Sydney for the time being and fourteen other persons of whom eleven persons namely seven men and four women shall be appointed by the Syngd and three persons shall be appointed by the Archbishop of Sydney.
- 15. The Archbishop of Sydney for the time being shall be the President of the Colincit.
- 6. A. Chairman may be appointed by the Council from amongst its members who shall in the absence of the President preside at all meetings of the Council and in the absence of the President and of the Chairman the members present shall from amongst their number elect a Chairman of the day.
- 7. At meetings of the Council four members shall form a outrum. In case of an equality of votes the Chairman of the day shall have a casting vote in addition to a deliberative vote.
- from three consecutive meetings of the Council shall have been absent from three consecutive meetings of the Council without leave or if any member shall in the opinion of at least three-fourths of the members for the time being of the Council become physically or menfally unfit or neglect to perform or become incapable of performing the duties of his office the seat of such member may be declared vacant by the Council.
- 9. Any member of the Council shall ipso facto cease to be a member if he shall resign his seat on should his seat be declared yacant in physicance of Clause 8 hereoft.
- 10. Whenever a vacancy shall be occasioned if the Council of the said School either by the death or resignation of any member, appointed by Synad or by virtue of Clause 8 hereof such vacancy when the Synad is not in session shall be filled by the appointment of a new member or members by he Standing

Committee of the Synod. Any person so appointed shall remain in office only until the next ordinary session of the Synod.

11. The first members other than the Archbishop shall include the following:—

- 12. At each ordinary session of Synod four of the eleven members of the Council appointed by Synod shall retire from office but shall be eligible for re-appointment. Such members shall retire in rotation according to the length of time of office. Provided that where the members have held office for an equal duration of time the member to retire may be determined by ballot taken amongst the members of the Council, or failing them by the Chairman at any meeting of the Council.
- 18. With respect to the members of the Council appointed by the Archbishop whenever there shall be a vacancy as aforesaid such vacancy shall be filled up by the appointment of a new member by the Archbishop.
- 14. The Council shall manage and carry on the said School and its affairs and may make such arrangements financial or otherwise for the benefit development extension, and improvement of the said School and of the assets thereto belonging, and the lands and premises used in conjunction therewith as the Council may from time to time think fit. And without limitation of the general powers hereinbefore conferred the said Council may borrow moneys and/or charge the said assets or any part or parts thereof to secure repayment thereof and interest and may invest moneys in hand from time to time in the purchase of lease of real or personal estate of time in the purchase of deem fit and may agguite by nurchase or lease premises in the

management of the affairs of the said School and shall further determine the course of instruction to be imparted in the said School and all matters in connection with the order and discipline thereof and shall manage the property and finances of the School in the manner in which to it may appear expedient for the benefit of the said School. All moneys derived from the assets and the conduct of the said School after payment of all liabilities shall be applied for its benefit.

- 15. Subject to the provisions hereof the Council may regulate its own proceedings and for that purpose shall have power to make rescind or alter regulations from time to time and may appoint and/or employ such officers as it may deem necessary,
- 16. The said School and the assets from time to time thereto belonging may be held upon trust by the Archbishop of Sydney or by such other person or persons as the Council may from time to time determine.
  - "117. The members of the Council shall be indemnified out of the assets of the said School against all loss or liability to which they or any of them may be subject by reason of being or having been members or a member of the said Council.
  - 18. The Council shall pay all expenses of and incidental to the acquisition and establishment of the School.
  - . 19. The Council may in the exercise of the powers or the performance of any of the duties hereinbefore mentioned by resolution authorise any person or persons to do any act or sign or execute any document on its behalf.
  - 20. The Council shall at least once in every year and also whenever a resolution shall be passed and communicated to them by the Sylind of the Diotese of Sydney in that behalf report their proceedings and progress and conditions of the school to the Synod and at the same time present a statement of receipts and expenditure and a balance sheet duly audited showing the financial position of the School.
  - 21. In the absence from the State or the incapacity of the Archbishop of Sydney, or during the vacancy of the Sec, the

powers and/functions vested in the Archbishop by this Ordinance shall be exercised by the Administrator for the time being.

22. The Ordinance may be cited as "The Church of England Grammar School for Girls Cremorne Ordinance of 1925."
