THE CHURCH OF ENGLAND HOMES CONSTITUTION (AMENDMENT)  
ORDINANCE 1983

NO. 9 1983

AN ORDINANCE to amend the Church of England Homes  
Constitution Ordinance 1978 as set out herein.


WHEREAS the Standing Committee of the Synod of the Diocese  
of Sydney, in the name and place of such Synod, ordained,  
directed and ruled by the Church of England Homes  
Constitution Ordinance 1978, being No. 7 of 1978  
5 (hereinafter referred to as the "Constitution Ordinance"),  
that the provisions of the Constitution Ordinance shall form  
the Constitution for the Church of England Homes in the  
place and stead of the provisions in the Church of England  
Homes Constitution Ordinance 1930 AND WHEREAS the  
10 management, conduct and control of the Church of England  
Homes (hereinafter called "the Society") is vested by the  
said Constitution Ordinance in a Committee which is a Body  
Corporate incorporated under the provisions of the Church of  
England (Bodies Corporate) Act 1938 known as The Committee of  
15 the Church of England Homes (hereinafter called "the  
Committee") AND WHEREAS clause 24 of the said Constitution  
Ordinance provides that "a request of The Committee for the  
alteration of this Constitution shall not be submitted to  
the Standing Committee or the Synod except with the approval  
20 of a resolution of a duly convened annual or extraordinary  
general meeting by a majority of not less than two-thirds of  
the members present at such meeting and entitled to vote in  
respect thereof under the provisions of this Constitution"  
AND WHEREAS The Committee requests the alteration of the  
25 Constitution Ordinance by deleting from Clauses 4(b) and  
4(c) thereof the words "social welfare" where appearing in  
each case and substituting for those words in each case the  
word "charitable" AND WHEREAS a duly convened extraordinary


30 general meeting of members of the society on 14th December  
 1982 unanimously approved the said request of the Committee  
 AND WHEREAS it is now expedient to alter the Constitution  
 Ordinance in the manner hereinafter provided  
 NOW the Standing Committee of the Synod of the Diocese of  
 Sydney in the name and place of such Synod HEREBY ORDAINS  
 35 DIRECTS AND RULES as follows:-

1. The Church of England Homes Constitution Ordinance 1978  
 be amended by deleting from Clause 4(b) and 4(c) thereof  
 the words "social welfare" where appearing in each case  
 and substituting for those words in each case the word  
 40 "charitable".
2. This Ordinance may be cited as "The Church of England  
 Homes Constitution (Amendment) Ordinance 1983".
3. The Constitution Ordinance as amended by this Ordinance  
 may be known as "The Church of England Homes  
 45 Constitution Ordinance 1978-1983" and Clause 2 of the  
 Constitution Ordinance is amended accordingly.


