AN ORDINANCE to vary the trusts of the various Trust Funds described in the schedule hereto. WHEREAS the Trust Funds named in the First and Second Schedules hereto (hereinafter collectively referred to as "the said Trust Funds") have by will, declaration of trust or other act, deed or settlement been established or commenced by or on behalf of the persons or entities after whom the said Trust Funds have been named AND WHEREAS the said Trust Funds were established to benefit specific purposes and objects in connection with the Church of England Homes AND WHEREAS the management conduct and control of the Church of England Homes (hereinafter called "the Society") is vested by its constitution in a Committee which is a body corporate incorporated under the provisions of the Church of England (Bodies Corporate) Act, 1938 known as The Committee of the Church of England Homes AND WHEREAS by reason of circumstances which have arisen subsequent to the creation of the said Trust Funds it is inexpedient to carry out and observe the respective trusts attaching to each Trust Fund to the extent to which such trusts are hereby varied NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of such Synod HEREBY ORDAINS DIRECTS AND RULES as follows:-

1. By reason of circumstances which have arisen subsequent to the creation of the Trust Funds named in the First Schedule hereto it has become impossible or inexpedient to carry out or observe the trusts attaching to those Trust Funds and that it is therefore expedient to vary such trusts to enable the capital and income thereof to be applied for the general purposes of the Society.

2. By reason of circumstances which have arisen subsequent to the creation of the Trust Funds named in the Second Schedule hereto it has become impossible or inexpedient to carry out or observe the trusts attaching to those Trust Funds and that it is therefore expedient to vary such trusts to enable the capital and income thereof to be held for the education and recreation of such children as are cared for by the Society from time to time as The Committee of the Church of England Homes considers appropriate.

3. That the moneys or investments comprising the Trust Funds named in the First Schedule hereto shall be received by The Committee of the Church of England Homes and such part thereof as shall be required for that purpose shall be applied in payment of the costs charges fees and expenses of and incidental to this Ordinance and the balance shall be held and applied by the said Committee for the benefit of the Society to apply the capital or the income arising from any investment thereof for the general purposes of the Society.

4. That the moneys or investments comprising the Trust Funds named in the Second Schedule hereto shall be received by The Committee of the Church of England Homes and the said Committee shall hold the capital and the income arising therefrom for the education and recreation of such children as are cared for by the Society from time to time as The Committee of the Church of England Homes considers appropriate.

5. This Ordinance may be cited as "The Church of England Homes (Variation of Trust Funds) Ordinance 1981".
