Church of England Provident Fund (Sydney) Ordinance, 1961

No. 38, 1961.

An Ordinance to increase certain benefits under the Church of England Provident Fund (Sydney) Ordinance, 1944-1955 and for purposes connected therewith.

The Synod of the Diocese of Sydney ordains as follows:-

- This Ordinance—
 - (a) may be cited as the Church of England Provident Fund (Sydney) Ordinance, 1961; and
 - (b) shall be read and construed with the Church of England Provident Fund (Sydney) Ordinance, 1944-1955 (herein called "the Principal Ordinance").
- 2. The respective rates prescribed by the Principal Ordinance or determined under Clause 27A thereof of superannuation annuities and widows' and orphans' pensions the payment of which commenced before the first day of July, 1960 and all instalments thereof are as from that date increased by twelve per centum.
- 3. The respective rates prescribed by the Principal Ordinance or determined under Clause 27A thereof of superannuation annuities and widows' and orphans' pensions the payment of which has commenced or may commence during the period commencing on the first day of July, 1960 and ending on the thirtieth day of June, 1965 and all instalments thereof are hereby increased as follows:
 - (a) in the case of superannuation annuities—by twelve per centum;
 - (b) in the case of widows' and orphans' pensions—at the rate set out in the second column of the Table set out hereunder applicable to the number of complete years for which subscriptions have been paid set out in the first column of the Table.

- 4. The amount of the increase of instalments of superannuation annuities and widows' and orphans' pensions paid before the date of assent to this Ordinance shall be paid to the persons entitled thereto as soon as possible after such date.
 - Nothing in this Ordinance shall be deemed to increase any benefit under the Principal Ordinance except in the cases and to the extent hereinbefore provided.
