# Cost Recoveries (Parochial Network) Amendment Ordinance 2011

No 22, 2011

### **Long Title**

An Ordinance to update the terminology used to describe the costs recovered from parishes through the variable component of the parochial cost recoveries charge.

#### **Preamble**

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

#### 1. Name

This Ordinance is the Cost Recoveries (Parochial Network) Amendment Ordinance 2011.

### 2. Amendment of the Cost Recoveries Framework Ordinance 2008

The Cost Recoveries Framework Ordinance 2008 is amended as follows -

(a) delete the long title and insert instead the following –

"An Ordinance to authorise the recovery of certain costs incurred in relation to parochial clergy and the network of parishes in the Diocese, and to provide for the calculation of the net operating receipts of a parish.", and

- (b) delete each occurrence of the words "property costs" in clauses 2(2)(b), 4, 5(1) and 5(3) and insert instead the words "parochial network costs", and
- (c) delete the first occurrence of the word "parishes" in clause 2(2)(b) and insert instead the words "the network of parishes in the Diocese".

#### 3. Amendment of the Parochial Cost Recoveries Ordinance 2009

The Parochial Cost Recoveries Ordinance 2009 is amended as follows -

- (a) delete each occurrence of the words "property costs" in recitals A and B and clauses 2 and 3(2)(a) and insert instead the words "parochial network costs", and
- (b) delete the first occurrence of the words "property costs" in the definition of determined percentage in paragraph 2 of the Schedule and insert instead the words "parochial network costs", and
- (c) delete the words "property costs" in paragraph (a) of the proviso to the definition of determined percentage in paragraph 2 of the Schedule and insert instead the words "parochial network costs associated with property".

## 4. Miscellaneous amendments

Each occurrence of the matter "Assessment and Charges Ordinance 1975" in -

- (a) clauses 6(a)(iii), 6(c) and 8(1)(c) of the Parishes Ordinance 1979, and
- (b) clauses 5(1)(a)(iii) and 5(1)(c) of the Nomination Ordinance 2006,

is deleted and the matter "Cost Recoveries Framework Ordinance 2008" is inserted instead.
