ANGLICAN DIOCESAN SCHOOLS AMENDMENT ORDINANCE 1986

NO. 25, 1986

AN ORDINANCE to amend the Council for the
Promotion of Sydney Anglican Diocesan Schools
Ordinance 1947-1983

The Standing Committee of the Synod of the Diocese of Sydney in
the name and place of the said Synod HEREBY ORDAINS DIRECTS RULES
AND DECLARES as follows;

1. (1) This ordinance may be cited as "The Council for the
Promotion of Sydney Anglican Diocesan Schools Amendment Ordinance
1986".

(2) The Council for the Promotion of Sydney Anglican
Diocesan Schools Ordinance 1947-1983 is hereinafter referred as
the "principal ordinance".

(3) The principal ordinance as amended by this ordinance may
be cited as "The Council for the Promotion of Sydney Anglican
Diocesan Schools Ordinance 1947-1986" and Clause 22 thereof is
amended accordingly.

2. Sub-clause (b) of Clause 3 of the principal ordinance is
amended by deleting the words and figures "Four (4)" and by
substituting in their place "Six (6)" and by deleting "two (2)" in
two places therein and by substituting in their place "three
(3)".

3. Sub-clause (c) of clause 6A of the principal ordinance is
amended by deleting the words "for three (3) years but shall be
eligible for re-election by Standing Committee" and substituting
in their place the words "until his or hers replacement is
elected". The said sub-clause is further amended by adding the
following sentences at the end thereof namely: "The election of
any Standing Committee appointee shall take place as soon as
possible after the First Ordinary Session of Synod and all
members shall be eligible for re-election."

4. Sub-paragraph (b) of paragraphs (i) and (ii) of sub-clause
(e) of clause 6A of the principal ordinance is amended by
inserting after the word "officio" the following words that is to
say: "or such alternate for the Chairman, being a member of the
Council, as the Council may appoint for such period and upon such
terms and conditions as it shall determine."

5. Sub-paragraph (c) of paragraphs (i) and (ii) of sub-clause
(e) of clause 6A of the principal ordinance is amended by
inserting after the word "officio" the following words that is to
say: "or such alternate for the Secretary, being a member of the
Council, as the Council may appoint for such period and upon such
terms and conditions as it shall determine."

6. Sub-paragraph (e) of paragraph (i) of sub-clause (e) of
clause 6A of the principal ordinance is amended by inserting
after the word "Council" the following words, that is to say, "or
in circumstances where the proviso to the next immediately
succeeding sub-paragraph (f) applies then also one (1) additional
person who is also for the time being a member of the Council".

7. Sub-paragraph (f) of paragraph (i) of sub-clause (e) of clause 6A of the principal ordinance is amended by adding the following words, that is to say, "provided that if such person so elected is also appointed either as Chairman of the School Board under sub-paragraph (a) hereof or as Deputy Chairman under sub-paragraph (d) hereof then the Council may appoint one (1) additional person who is for the time being a member of Council in addition to the two (2) persons referred to in sub-paragraph (e) hereof which additional person shall hold office subject to the terms of this ordinance but shall cease to hold such office in the event that the person elected as Chairman or Deputy Chairman as aforesaid ceases to hold such position as Chairman or Deputy Chairman as the case may be but shall be eligible for reappointment as the Council may determine".

8. The Schedule to the principal ordinance is amended so as to delete the words "St Luke's Preparatory School" and to substitute the words "Roseby Preparatory School".
