The Council for the Promotion of Sydney Church of England Diocesan Schools Mortgage (Amendment) Ordinance of 1949.

## No. 5, 1949.

AN ORDINANCE to amend "The Council for the Promotion of Sydney Church of England Diocesan Schools Mortgage Ordinance 1948" by defining the real property thereby directed to be mortgaged and for puposes connected therewith.

WHEREAS before The Council for the Promotion of Sydney Church of England Diocesan Schools Mortgage Ordinance 1948 (hereinafter called "the Principal Ordinance") was passed the land situated in Gladstone Road Leura comprised in Certificate of Title Volume 2480 Folio 127 (hereinafter called "the said land") had been acquired and was then and is now held in trust for the use and benefit and purposes of the School referred to in the Principal Ordinance as the Leura Preparatory School for Boys and now known as "The MacLaurin School" but the said land was inadvertently omitted from the Schedule to the Principal Ordinance.

AND WHEREAS in the said Schedule the words "Danebrook School" were inserted instead of the words "Danebank School."

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod declares directs and ordains as follows:—

1. By reason of the circumstances hereinbefore recited subsequent to the creation of the trusts to which the said land is subject it appears that the said land should be mortgaged in accordance with Clause I of the Principal Ordinance and accordingly such mortgage is hereby directed.

2. The Schedule to the Principal Ordinance is amended:----

- (a) by omitting the word "Danebrook" and inserting in lieu thereof the word "Danebank";
- (b) by inserting after the word "Registered" secondly occurring the words and figures "Volume 2480 Folio 127 and."

 (1) This Ordinance may be cited as "The Council for the promotion of Sydney Church of England Diocesan Schools Mortgage (Amendment) Ordinance 1949" and shall be read and construed with the Principal Ordinance.

(2) The Principal Ordinance as amended by this Ordinance may be cited as "The Council for the Promotion of Sydney Church of England Diocesan Schools Mortgage Ordinance 1948.1949."
