Delegation of Powers and Ordinance Procedure Ordinance and Wollongong Zone Council Ordinance Amendment Ordinance 1976

## No. 35, 1976

- AN ORDINANCE to amend the Delegation of Powers and Ordinance Procedure Ordinance 1973 and the Wol-

longong Zone Council Ordinance 1972-1973.

WHEREAS It is expedient that further provision be made for the Wollongong Zone Council to exercise the powers and functions confered on it under the Delegation of Powers and Ordinance Procedure Ordinance 1973 NOW the Synod of the Diocese of Sydney HEREBY DECLARES RULES ORDAINS AND DIRECTS as follows:

 (1) This Ordinance may be cited as the "Delegation of Powers and Ordinance Procedure Ordinance and Wollongong Zone Council

Ordinance Amendment Ordinance 1976".

(2) The Delegation of Powers and Ordinance Procedure Ordinance 1973 as amended by this Ordinance may be cited as "Delegation of Powers and Ordinance Procedure Ordinance 1973-1976" and in any reprint of that Ordinance clause 1 shall be amended accordingly.

reprint of that Ordinance clause I shall be amended accordingly.

(3) The Wollongong Zone Council Ordinance 1972-1973 as amended by this Ordinance may be cited as "Wollongong Zone Council Ordinance 1972-1976" and in any reprint of that Ordinance

clause 16 (1) shall be amended accordingly.

2. Clause 20 of the Delegation of Powers and Ordinance Procedure Oridinance 1973 is amended by inserting the brackets and numeral "(1)" after the clause number and by inserting the following subclauses at the end of that clause:

"(2) For the purpose of this Ordinance only —

(a) The Wollongong Zone Council is hereby empowered to appoint a committee from amongst its members to exercise the powers and functions conferred on the Wollongong Zone Council under this Ordinance; and

(b) Such exercise of any power or function by any duly appointed committee shall be deemed to be an exercise

thereof by the Wollongong Zone Council."

 Clause 11 (a) of the Wollongong Zone Council Ordinance 1972-1973 is amended by omitting "16 of the Land Ordinance Procedure and Delegation of Powers Ordinance 1926-1971" and by inserting "20 of the Delegation of Powers and Ordinance Procedure Ordinance 1973".
