Diocesan Missions Ordinance Amending Ordinance 1975

No. 40, 1975

AN ORDINANCE to amend the composition of the board of management known as "The Board of Diocesan Missions".

WHEREAS the board of management known as "The Board of Diocesan Missions" is composed of a President and fifteen other members ten of whom are elected by the Synod and five of whom are appointed by the Archbishop and whereas the said board desires that its composition be changed to a President and twenty other members fifteen of whom are elected by the Synod, two of whom are appointed by the Archbishop and three of whom are appointed by the President and the seventeen other members NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

- 1. (1) The Diocesan Missions Ordinance of 1927 as amended by the Diocesan Missions Ordinance Amending Ordinance of 1942 is hereinafter referred to as the "Principal Ordinance".
- (2) This Ordinance may be cited as the "Diocesan Missions Ordinance Amending Ordinance 1975".
- (3) The Principal Ordinance as amended by this Ordinance may be cited as the "Diocesan Missions Ordinance 1927-1975" and clause 9 of the Principal Ordinance is amended accordingly.
- 2. The Principal Ordinance is hereby amended as follows:-
 - (a) By the substitution of the word "twenty" for the word "fifteen" in clause 3,
 - (b) By the substitution of the word "fifteen" for the word "ten" in paragraph (a) of clause 5,
 - (c) By the substitution of the word "two" for the word "five" in paragraph (b) of clause 5,
 - (d) By the insertion of the following paragraph after paragraph
 (b) of clause 5:—
 - "(c) Three persons shall be appointed by the other members of the Board at or subsequent to the first meeting of the Board following the first ordinary session of each Synod and they shall hold office until the first ordinary session of the succeeding Synod" and
 - (e) By the omission of the second sentence of clause 7.
- 3. All vacancies created in the membership of the Board by this Ordinance shall be filled by the Standing Committee by resolution thereof. All persons appointed under this clause shall hold office until the next ordinary session of this Synod but shall be eligible for election. All persons who hold office as members of the Board on the date on which this Ordinance is assented to shall continue to hold office until such time as they retire under the Principal Ordinance.
