Endowment of the See (Chatswood) Land Sale Ordinance 2014

No 17, 2014

Long Title

An Ordinance to authorise the sale of certain property at Chatswood and for related purposes.

Preamble

- A. Anglican Church Property Trust Diocese of Sydney (the "Property Trust") is the registered proprietor of land in certificate of title folio identifier 43/14799 known as 229 Fullers Road, Chatswood (the "Chatswood Land").
- B. The Chatswood Land is held upon the trusts set out in clause 4 of the Endowment of the See Capital Ordinance 2012 as part of the Capital Fund under that Ordinance (the "Capital Fund").
- C. By reason of circumstances which have arisen after the creation of the trusts on which the Chatswood Land is held it is expedient that it be sold and that the proceeds of sale be applied in the manner set out in this ordinance.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Endowment of the See (Chatswood) Land Sale Ordinance 2014.

2. Declaration

By reason of circumstances which have arisen after the creation of the trusts on which the Chatswood Land are held it is expedient that they be sold and that the proceeds of sale be applied in the manner set out in this ordinance.

3. Power of sale

The Property Trust is authorised to sell the Chatswood Land within 3 years after the date of assent to this Ordinance and thereafter only with the consent of the Standing Committee given by resolution whether given before or after this date.

4. Application of proceeds

The proceeds of sale, after payment of the costs and expenses of and incidental to this Ordinance and the sale of the Chatswood Land, are to be paid to the Property Trust and that part of the Capital Fund comprising the sale proceeds may be applied as follows –

- (a) first, in payment of any goods and services tax (as defined in the A New Tax System (Goods and Services Tax) Act 1999) in connection with the sale, and
- (b) the balance, in and towards the costs of and incidental to the purchase of a residence or residences to house such senior clergy of the Diocese of Sydney as the Archbishop may determine from time to time.

5. Amendment to the Endowment of the See Capital Ordinance 2012

The Endowment of the See Capital Ordinance 2012 is amended by inserting the following at end of clause 4 in place of the full stop –

- ", and
- (d) in respect to that part comprising the Real Property, to provide housing for the Archbishop of Sydney and such other senior clergy of the Diocese as he may determine."
