## General Assessment Authorisation Ordinance Amendment Ordinance 1974

## No. 30, 1974

AN ORDINANCE to amend the provisions relating to allowable deductions under clause 14 of the General Assessment Authorisation Ordinance 1959-1972.

WHEREAS it is expedient to amend the provision relating to allowable deductions for new churches and church sites in clause 14 of the General Assessment Authorisation Ordinance 1959-1972 AND WHEREAS it is expedient to make further provision in the said clause for concessions of assessment on that portion of the total assessable income of a parish derived from branch churches which necessitate the services of additional full-time clergy in that parish NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

- 1. (1) This Ordinance may be cited as "General Assessment Authorisation Ordinance Amendment Ordinance 1974".
- (2) The General Assessment Authorisation Ordinance 1959-1972 is hereinafter called the "Principal Ordinance".
- (3) The Principal Ordinance as amended by this Ordinance may be cited as "General Assessment Authorisation Ordinance 1959-1974".
- 2. The Principal Ordinance is hereby amended by the deletion of clause 14 (2) (1) and by inserting in lieu thereof the following:—
  - "(1) Contributions not exceeding Thirty thousand dollars (\$30,000) in all for either or both of the following purposes:—
    - (i) money paid into a separate bank account for the purchase of a site for a new centre of worship in the parish and the erection thereon of a building for divine worship in an area where no such land or building was previously situated, being an area in which in the opinion of the Archbishop the provision of such land or building was desirable.
    - (ii) money paid for the erection of such building and/or the liquidation of the consequential debt on such land or building,

PROVIDED that this deduction shall not be applicable after five years from the first licensing of such building and shall apply only to the first building erected on the site."

- 3. The Principal Ordinance is further amended by inserting the following new paragraph at the end of clause 14 (2):—
  - "(p) For each branch church in a multiple church parish one quarter of the stipend paid to the surate of the said parish."
