AN ORDINANCE to accept and to apply the provisions of Determination No. V of 1945 intituled "A Determination to amend the Determination for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania, General Synod, October, 1916 (as amended, October, 1921)" in the order and good government of the Church of England within the Diocese of Sydney.

WHEREAS Determination No. V 1945 intituled "A Determination to amend the Determination for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania, General Synod, October, 1916 (As amended, October, 1921)" a copy whereof is contained in the Schedule hereto has been made by General Synod.

AND WHEREAS under Article No. 3 in the Schedule to the Church of England Constitutions Act Amendment Act of 1902 the Diocese may make Ordinances upon and in respect of all matters and things concerning the order and good government of the Church of England and the regulation of its affairs within the Diocese.

AND WHEREAS by an Ordinance assented to on 21st June, 1876, regulating the method of accepting Determinations of General Synod it was provided that the mode of acceptance of such Determinations should be by Ordinance.

AND WHEREAS it is expedient to accept and to apply the provisions of the said Determination No. V 1945 as hereinafter expressed.

The Synod of the Diocese of Sydney in pursuance of its powers under the said Act hereby ordains and rules as follows:—

The said Determination No. V 1945 is and the provisions therein contained are accepted and shall be applied in the order and good government of the Church of England within this Diocese in like manner as if the same were herein and hereby expressly ordained and ruled.

SCHEDULE.

GENERAL SYNOD OF THE DIOCESES IN AUSTRALIA AND
TASMANIA.

DETERMINATION V, SESSION, 1945.

A DETERMINATION to amend the Determination for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania, General Synod, October, 1916.

(As amended, October, 1921)

1. In the title after "1921" the following words shall be added: "and September, 1945."

2. Clause 1.—

- (a) After the words "A Chairman, who shall be also the" there shall be added the words "Board's Chief," and after the words "Executive Officer" the following words shall be omitted: "of the Board for routine work."
- (b) After the word "Clergymen" the word "and" shall be omitted and a comma added, and after the word "laymen" immediately following there shall be added the words "and women."
- (bb) Omit the words "one clergyman and one layman" where appearing before the words "by the representatives in this General Synod of the Dioceses in the Province of Queensland" and inserting in lieu thereof the words "two clergymen and one layman."
- (c) After the words "Six women, that is to say, one" all the words from "for each" to "Tasmania" inclusive shall be omitted and in lieu thereof the following words shall be substituted: "nominated by the Women's Auxiliary of the Australian Board of Missions in each of the four Provinces above-named, one nominated by the said Women's Auxiliary in the Dioceses of South Australia, and one nominated by the Women's Auxiliary in the Diocese of Tasmania."
- (d) The words "Such representatives of missions or missionary agencies as may be elected as hereinafter provided" shall be omitted.
- (e) After the words "Session of the General Synod" there shall be added the following words: "and the election of the Honorary Treasurer at the first meeting of the Board following each ordinary session of the General Synod."

3. Clause 2.—

- (a) The words "in the absence of..... a casting vote" shall be omitted.
- (b) The words "The Chairman" immediately following shall be omitted and in lieu thereof the word "He" shall be substituted .

4. Clause 4, sub-clause (iv). The words "and co-ordinate missionary effort" shall be omitted.

5. Clause 5.—

- (a) The word "places" before the words "as he may think fit" shall be omitted, and in lieu thereof the words "a place" shall be substituted.
- (b) After the words "Ten shall form a quorum" the following words shall be added: "In the absence of the Primate the Board shall elect one of its members as Acting-President from day to day. In case of an equality in the voting on any question the President or Acting-President shall have a casting vote."
- (c) The sentence "The Board shall have power..... place of meeting" shall be taken from their present position and inserted immediately after the words "work is concluded."

6. Clause 16.—After the words "every ordinary session" the words "and a discussion.....of the session" shall be omitted.

7. Clauses 6, 7, 8, 9, 14 and 15 shall be omitted, and clauses 10, 11, 12, 13 and 16 re-numbered.
