WHEREAS: A. The Constitution Alteration (Cefinition of "Member") Canon 1985 and the Constitution Alteration (Definition of "Member") Bill 1985 (hereinafter called "the Canon and Bill") were made by the General Synod of the Anglican Church of Australia in 1985.

B. Copies of the Canon and Bill are contained in the Schellules hereto. It is expedient that the Canon and Bill be assented to by the Synod of this Diocese.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows: Assent to Canon and Bill

1. The Synod hereby assents to the Canon and Bill. Citation

2. This Ordinance may be cited as the "General Synoi — Constitution Alteration (Definition of "Member") Canon and Bill 1985 Assenting Ordinance 1986".

FIRST SCHEDULE A Canon to alter the Constitution to Amend the Definition of "Member". The General Synod prescribes as follows:

1. The Constitution is altered to the extent provided in the 25 Schedule to this Canon. 2. This Canon may be cited as "Constitution Alteration (Definition of "Member") Canon 1985". Schedule

1. Section 74. (1) is altered by omitting from the definition of "Member of this Church" the words "not a member of any other Church" and substituting the words "and of no Church which is not in communion with this Church".

SECOND SCHEDULE Bill to alter the Constitution to Amend the definition of 35 "Member".

The General Synod prescribes as follows: 1. The Constitution is altered to the extent provided in the Schedule to this Bill.
