Glebe Administration Ordinance 1930-1970 Amendment Ordinance 1971

No. 23, 1971

An Ordinance to further amend the Glebe Administration Ordinance 1930-1970.

Whereas it is expedient to confer certain additional powers upon the Glebe Administration Board and to further amend the Glebe Administration Ordinance 1930-1970 (hereinafter called the "Principal Ordinance") NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY DECLARES RULES ORDAINS AND DIRECTS as follows:—

- 1. The Principal Ordinance is hereby amended as follows:-
 - (a) by the insertion of "(1)" before the opening words of Clause 13,
 - (b) the insertion of the words "demolish any existing buildings in the said Glebes" after the words "in the said Glebes" in paragraph (e) of Clause 13, and
 - (c) the insertion of the following as sub-clause (2) of Clause 13—
 - "(2) In addition to the powers, authorities, duties and functions conferred or imposed by sub-clause (1) of this Clause, the Board shall have power—
 - (a) to receive money on deposit or loan,
 - (b) to borrow or raise or secure the payment of money by the issue of debentures, perpetual or otherwise, charged upon all or any part of the said Glebes or any other property vested in the Board and to purchase, redeem or pay off any such securities.
 - (c) to invest, in the purchase of real property, the proceeds of any property sold by the Board pursuant to the authority of any ordinance, and
 - (d) to exercise and perform the powers, authorities, duties and functions delegated to the Board from time to time by the Standing Committee".
- (a) This Ordinance may be cited as "Glebe Administration Ordinance 1930-1970 Amendment Ordinance 1971".

- (b) The Principal Ordinance as amended by this Ordinance may be cited as "Glebe Administration Ordinance 1930-1971", and by the C.E.N.E.F. and Glebe Administration Board Variation of Trusts Ordinance 1971.
- (c) Sub-clause (2) of Clause 12 of the C.E.N.E.F. and Glebe Administration Board Variation of Trusts Ordinance 1971 is hereby repealed.
