## GLEBE ADMINISTRATION ORDINANCE 1930-1977 AMENDING ORDINANCE (NO. 2) 1981

## No. 44 1981

AN ORDINANCE to add to the powers of Glebe Administration Board.

WHEREAS it is expedient that the number of members of Glebe Administration Board (the Board) required to sign any instrument to which the common scal of the Board has been affixed be reduced to two and WHEREAS it is expedient that the Board have power to guarantee the obligations of Sydney Diocesan Secretariat NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

- 1. (1) This ordinance may be cited as "Glebe Administration Ordinance
  1930-1977 Amending Ordinance (No. 2) 1981".
  - (2) Glebe Administration Ordinance 1930-1977 is hereinafter called the "principal ordinance".
  - (3) Glebe Administration Ordinance 1930 Amending Ordinance 1981 is hereinafter called the "1981 Ordinance".
  - (4) Clause 1(3) of the 1981 Ordinance is hereby repealed.
  - (5) The principal ordinance as amended by the 1981 Ordinance and by this ordinance may be cited as "Glebe Administration Ordinance 1930-1981" and Clause 21 of the principal ordinance is amended accordingly.
- 2. The principal ordinance as amended by the 1981 Ordinance is hereby amended as follows:
  - by inserting the following as clause 9

    "The common seal of the Board shall not be affixed to any instrument except in pursuance of a resolution passed at a meeting of the Board.

    Every instrument to which the common seal is so affixed shall be signed by two members of the Board."

- (2) by inserting "and financial accommodation made available to the Board" after "payment of money" in paragraph (b) of Clause 13(2),
- (3) by inserting "or by any other mortgage or charge over" after "upon" in paragraph (b) of Clause 13(2),
- (4) by inserting the following paragraph after paragraph (ba) of Clause 13(2)
  - "(bb) to give guarantees and indemnities for the payment of money or the performance of contracts or obligations by Sydney Diocesan Secretariat and to secure the same; to secure or undertake in any way the repayment of moneys lent or advanced to or financial accommodation made available to or the liabilities incurred by Sydney Diocesan Secretariat;" and
- "(5) by inserting the following after Sub-clause (4) of Clause 13

  "(5) No purchaser, mortgagee, lessee, lender or other person on any sale, exchange, mortgage, lease from or any loan or provision of other financial accommodation to or in relation to the Board shall be concerned to see or enquire into the purpose, necessity or propriety thereof, or the power of the Board in relation thereto, or the mode of exercising the same nor be affected by notice that the exercise of the power is unauthorised, irregular or improper nor be concerned to see to the application or disposition of any purchase, mortgage or other money or rent paid by him."
