Glebe Administration Ordinance 1930 Further Amendment Ordinance, 1964

No. 8, 1964.

An Ordinance to amend Clause 14 (2) of the Glebe Administration Ordinance 1930-1964 and for purposes incidental thereto.

Whereas by the Glebe Administration Ordinance 1930-1964 provision is made by Clause 14 (2) thereof to apply the rents issues and profits of St. Philip's Glebe in a certain manner and as to the remainder of the said rents issues and profits for such purposes as shall be determined by Synod And Whereas it is expedient to apply portion of the said remainder for or towards the purposes and to the extent hereafter set out NOW therefore the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod and by virtue of the powers vested in it pursuant to the Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961 and all other powers thereunto it enabling hereby ORDAINS RULES AND DIRECTS as follows:

- 1. This Ordinance may be cited as "Glebe Administration Ordinance 1930-1964 Further Amendment Ordinance 1964."
- 2. The "Glebe Administration Ordinance 1930-1964" is in this Ordinance referred to as "the Prinicpal Ordinance."
- 3. The Prinicpal Ordinance as amended by this Ordinance may be cited as "Glebe Administration Ordinance 1930-1964."
- 4. Clause 14 (2) of the Principal Ordinance is amended by inserting the following additional sub-clauses after Sub-clause (q)—
 - (q2) In setting aside a sum not exceeding One thousand five hundred pounds (£1,500) to be paid to the Diocesan Immigration Department to provide for the salary and related expenses of a chaplain for foreign migrants in the Diocese of Sydney.
 - (q3) In setting aside a sum not exceeding One thousand pounds (£1,000) to be paid to the Diocesan Church of England Youth Department for work and related expenses among youth in the inner city of Sydney.
 - (q4) In setting aside a sum not exceeding One thousand pounds (£1,000) to be paid to the Diocesan Church of England

Youth Department for the salary and expenses of an Assistant Youth Chaplain and Director of boys' work in the Diocese of Sydney.

- (q5) In setting aside a sum not exceeding One thousand pounds (£1,000) to be paid to the Home Mission Society towards the stipend and expenses of a Chaplain to work in the Lidcombe State Hospital and Home.
- 5. The provisions contained in the preceding clause shall operate for a term of one year from the date of passing of this Ordinance but they or any of them may be extended from time to time and for such time as Standing Committee may by resolution determine.
