## Glebe Administration Ordinance Further Amendment Ordinance 1968

## No. 18, 1968.

An Ordinance to amend Clause 14 (2) of the Glebe Administration Ordinance 1930-1968.

WHEREAS by the Glebe Administration Ordinance 1930 Further Amendment Ordinance 1964 (No. 8, 1964) Clause 14(2) of the Glebe Administration Ordinance 1930-1968 (hereafter called the Principal Ordinance) was amended by inserting inter alia an additional sub-clause (q2) in such Clause And whereas it is expedient to delete the said sub-clause (q2) AND WHEREAS by Ordinance No. 16, 1966 entituled "Glebe Administration Ordinance 1930-1965 Amendment Ordinance 1966", sub-clause (q7) was inserted after sub-clause (q6) in Clause 14 (2) of the Principal Ordinance therein referred to and as further amended by Glebe Administration Ordinance Further Amendment Ordinance 1967 (No. 13, 1967) NOW therefore the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod and by virtue of the powers vested in it pursuant to the Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961 and all other powers thereunto it enabling HEREBY ORDAINS RULES AND DIRECTS as follows: --

- 1. This Ordinance may be sited as "Glebe Administration Ordinance Further Amendment Ordinance 1968".
- 2. The Glebe Administration Ordinance 1930-1967 is in this Ordinance referred to as the "Principal Ordinance".
- 3. The Principal Ordinance as amended by this Ordinance may be cited as Glebe Administration Ordinance 1930-1968.
- 4. Sub-Clause (q2) of Clause 14(2) of the said Principal Ordinance as amended is repealed as and from the first day of April, 1968.
- 5. Sub-Clause (q7) of Clause 14(2) of the said Principal Ordinance is amended as follows:—
  - (i) By deleting the words and figures "Twenty Five Thousand (25,000)" and inserting in their place the words and figures "Sixty Thousand (60,000)".
  - (ii) By deleting the words "General Assessment" and inserting in their place "Special Purposes Assessment".

(iii) By deleting the figures "1968" and inserting in their place figures "1969".
