
*Glebe Administration Ordinance Further Amendment
Ordinance 1970*

No. 32, 1970

AN ORDINANCE to amend Clause 14 of the Glebe Administration Ordinance 1930-1968 as amended by the Glebe Administration Ordinance Amendment Ordinance 1970.

WHEREAS by the Glebe Administration Ordinance 1930-1968 as amended by the Glebe Administration Ordinance Amendment Ordinance 1970 (the Glebe Administration Ordinance 1930-1968 as amended by the Glebe Administration Ordinance Amendment Ordinance 1970 is hereinafter called the "Principal Ordinance") provision has been made for the application of the rents, issues and profits arising from all of the glebes managed and controlled by the Glebe Administration Board (hereinafter called "the Board") pursuant to the Principal Ordinance other than the Bishopthorpe Estate AND WHEREAS it is expedient for that provision to be amended AND WHEREAS by reason of circumstances which have arisen subsequent to the trusts upon which the glebes managed and controlled by the Board pursuant to the Principal Ordinance other than Bishopthorpe Estate and the rents, issues and profits thereof are now held it is inexpedient to carry out and observe the same to the extent to which such trusts are hereby varied and modified NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY DECLARES DIRECTS RULES AND ORDAINS as follows:—

1. This Ordinance may be cited as "Glebe Administration Ordinance Further Amendment Ordinance 1970".
2. The Principal Ordinance as amended by this Ordinance may be cited as "Glebe Administration Ordinance 1930-1970".
3. Clause 3 of the Glebe Administration Ordinance Amendment Ordinance 1970 is hereby repealed.
4. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the rents, issues and profits arising from all the glebes held managed and controlled by the Board pursuant to the Principal Ordinance are held other than the Bishopthorpe Estate it is inexpedient to carry out and observe the same to the extent to which such trusts are hereby amended and varied and it is expedient that such rents, issues and profits be dealt with and applied in accordance with the Principal Ordinance as amended by this Ordinance.

5. Clause 14 of the Principal Ordinance is amended as follows:—

- (a) By omitting sub-clause (2) and inserting the following in lieu thereof—

“The Standing Committee shall, by resolution, determine annually upon the sum to be remitted to the Standing Committee. Such sum shall not exceed the greater of three-fourths of the gross surplus disclosed in the said statement or the sum which the Board may have notified the Standing Committee will be available to the Standing Committee from its income. Such sum shall be remitted to the Standing Committee at such time or times as the Standing Committee may determine and shall be held and applied by the Standing Committee for such purposes and in such manner as the Synod may by Ordinance from time to time determine.”

- (b) By omitting sub-clause (3) and inserting the following in lieu thereof—

“The Board may from time to time notify the Standing Committee that an amount being the whole or any part of any gross surplus not previously remitted to the Standing Committee pursuant to sub-clause (2) of this clause or this sub-clause is available for diocesan purposes. The Board shall remit to the Standing Committee so much of the said amount so notified as the Standing Committee may call upon it from time to time so to do. Any amount remitted to the Standing Committee pursuant to this sub-clause shall be held and applied by it for such purposes and in such manner as the Standing Committee shall by resolution determine.”

- (c) By adding the following new sub-clause (4)—

“The whole of any gross surplus not remitted to the Standing Committee pursuant to sub-clauses (2) or (3) of this clause shall be retained by the Board for the administration and development of the said glebes.”
