AN ORDINANCE to vary the trusts of certain land and moneys held by the Church of England Property Trust Diocese of Sydney and known as Holsworthy Glebe.

WHEREAS the Most Reverend the Archbishop acting in accordance with the Parishes and Provisional Districts Ordinance of 1925 created a new Provisional District known as Hammondville on the 30th March 1949 AND WHEREAS the Most Reverend the Archbishop informed the Standing Committee that as from the 28th June 1954 he had created a new Provisional District known as Hammondville with amended boundaries AND WHEREAS the boundaries of such Provisional District are set out in the Schedule hereto AND WHEREAS Thomas Moore conveyed to the Bishop of Australia the Moorebank Estate at Liverpool and set aside a portion of the land as a glebe for the incumbent of Holsworthy AND WHEREAS the said land was sold with the rest of the land under the authority of the Moorebank Estate Act AND WHEREAS the proceeds arising from the sale were invested from time to time and the income for a number of years was added to the principal AND WHEREAS the sum now represents investments totalling £810 and cash uninvested £5 0s. 6d. making a total of £815 0s. 6d. AND WHEREAS the income that arose from the said investments was paid to the incumbent of Liverpool from time to time in aid of his stipend AND WHEREAS no specified trusts have been declared in writing AND WHEREAS the Bishop of Sydney set aside as a glebe for Holsworthy two blocks of land at the rear of the present site and the said Holsworthy Church has been built on the land although no specific trusts have been declared AND WHEREAS by reason of the creation of the said Provisional District of Hammondville it has become inexpedient to carry out or observe the trusts upon which the said capital moneys and land are held and it is expedient to vary the said trusts in the manner hereinafter provided Now the Standing Committee in the name and in the place of the Synod of the Diocese of Sydney ordains and declares as follows:-

 By reason of circumstances subsequent to the creation of the trusts to which the land described in the second schedule to this Ordinance and the capital moneys referred to in the third schedule of this Ordinance are subject it has become inexpedient to carry out or observe such trusts or to deal with or apply the said land or the said capital moneys for the use or benefit of the Church of England in the Parish of Liverpool and it is expedient to vary the said trusts in the manner hereinafter provided.

- 2. The land described in the second schedule to this Ordinance and the capital moneys referred to in the third schedule to this Ordinance shall be held upon trust for the use or benefit of the Church of England within the Provisional District of Hammondville as from the 1st July 1954.
- 3. The said capital moneys referred to in the third schedule to this Ordinance may be applied in or towards the purchase or building of a Rectory in the said Provisional District.
- 4. This Ordinance may be cited as the "Hammondville-Holsworthy Variation of Trusts Ordinance 1954."

SCHEDULE.

- 1. The boundaries of the Provisional District are as follows: "Commencing at a point at the bridge over the George's River at Casula Railway Station thence following the course of the river northwards bearing eastwards and then southwards to the junction of the George's River and Mill Creek thence in a straight line from the junction to the commencement."
- 2. The land referred to is the whole of the land comprised in Certificate of Title Volume 2720, Folio 70, of which Lot 52 in deposited plan 2411 has been leased for 5 years from the 1st October 1953 at £52 per annum.
 - 3. The moneys referred to are invested in:-

Commonwealth Treasury Bonds 37 % 1952/4 ... £200

Commonwealth Treasury Bonds 31 % 1950/7 ... £300

Commonwealth Treasury Bonds 34 % 1960 ... £310

making a total of £810, Cash £5 0s. 6d., making £815 0s. 6d.
