No. 5, 1941

AN ORDINANCE to amend the Presentation and Exchange Ordinance 1933, to provide for the Rector of the Parish of Holy Trinity Sydney performing certain Diocesan Duties and for other purposes incidental thereto.

The Synod of the Diocese of Sydney ordains as follows:-

- 1. The provisions of the Presentation and Exchange Ordinance 1933 shall not apply to the Parish of Holy Trinity Sydney.
- 2. Whenever a vacancy exists in the incumbency of the said Parish the Archbishop shall nominate a duly ordained clergyman being in the Holy Order of Priesthood thereto, and provided such clergyman enters into and gives such written agreement and undertaking as is hereinafter provided the Archbishop may appoint and license him to the said incumbency.
- 3. A Clergyman, nominated as hereinbefore provided shall before being appointed and licensed to the said incumbency agree and undertake in writing to the satisfaction of the Archbishop as follows:—
 - (a) That in addition to performing his ministerial duties as Rector of the said Parish he will perform such Diocesan duties as the Archbishop shall from time to time determine and with or without special remuneration as the Archbishop shall decide.
 - (b) That if the Archbishop shall give written notice to the Churchwardens for the time being of the said Parish the Incumbent having had previous notice that he no longer requires the said clergyman to carry out the said Diocesan duties then at the expiration of three calendar months after the giving of such notice the appointment and license of the said clergyman shall be deemed to be revoked and the incumbency shall become vacant.
 - (c) That he will reside at the Rectory of the said Parish or such other residence as the Archbishop and a majority of the said Churchwardens shall from time to time determine.

(d) That he will preach in the Church of Holy Trinity Sydney on Sundays not less than thirty times each year of his incumbency.

The notice required by this section may be given by posting the same in a prepaid envelope addressed to the Churchwardens of the said Church.

- 4. The license issued to a clergyman nominated at appointed as aforesaid shall contain and be subject to the provisions of Clause 3 of this Ordinance.
- 5. In this Ordinance, unless inconsistent with the context, Archbishop shall have the same meaning as prescribed by the Presentation and Exchange Ordinance 1933.
- 6. This Ordinance may be cited as Holy Trinity Sydney Incumbency Ordinance 1941.
