AN ORDINANCE to vary the trusts upon which certain moneys held by Church of England Property Trust Diocese of Sydney are held for the benefit of the Parish of Jamberoo with Shellharbour.

WHEREAS by the "Jamberoo-Shellharbour Sale Ordinance 1955" the net proceeds of the land described in the schedule thereto were directed to be held upon trust to be applied in and towards the purchase of other land in the Parish of Jamberoo with Shellharbour AND WHEREAS part of the said proceeds have been so applied in the purchase of Lot 29 Deposited Plan 23432 having a frontage of 50' to Antrim Avenue Warilla AND WHEREAS the balance of the said proceeds amounted to the sum of Ninety one pounds seven shillings (£91 7s.) which is held by Church of England Property Trust Diocese of Sydney (hereinafter called the Corporate Trustee) in accordance with the provisions of the said Ordinance AND WHEREAS the said parish intended to apply the said sum towards the purchase of an allotment adjoining the said Lot 29 AND WHEREAS subsequent to the purchase of the said Lot the adjoining allotment No. 30 has been donated to the said Parish AND WHEREAS it is proposed to erect a church hall upon the said allotments AND WHEREAS it is inexpedient to carry out and observe the trusts upon which the said sum of Ninety one pounds seven shillings (£91 7s.) is now held and it is expedient that the said trusts be varied as hereinafter set out Now the Standing Committee of the Synod of the Diocese of Sydney in the Name and place of the said Synod Hereby Declares Ordinances and Directs as follows:—

1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the sum of Ninety one pounds seven shillings (£91 7s.) is held by the Corporate Trustee on behalf of the Parish of Jamberoo with Shellharbour it is inexpedient to carry out and observe the same and it is expedient that the said trusts be varied.

2. The said sum of Ninety one pounds seven shillings (£91 7s.) shall henceforth be held by the Corporate Trustee upon trust to apply the same in and towards the erection of a church hall upon the land situated in Antrim Avenue Warilla, in the said Parish being Lots 29 and 30 Deposited Plan 23432.
