An Ordinance to provide for the investment of capital moneys arising from certain Church Trust properties and the application of the income therefrom to authorise pooling such Church Trust properties for the purpose of investment and for averaging gains losses and interests to validate certain pooling of separate Church Trust properties for the purpose of investment heretofore made to vary the Trusts declared by certain documents dealing with Church Trust properties and for matters and things incidental to such investment and pooling and for other purposes.

WHEREAS by Indenture of Foundation of the Broughton Foundation Scholarship and Declaration of Trust bearing date the fifth day of April One thousand eight hundred and sixty-six entered (1866). of record in the office of the Supreme Court of New South Wales on the sixteenth day of April One thousand eight hundred and sixty-six and made between Stella Kemp of Sydney widow the Reverend Robert Allwood of Sydney clerk in holy orders Edward Parnell of Carrington Park on the Hunter River esquire and William Edmund Kemp of Sydney architect the executrix and executors of the last will and testament of Charles Kemp late of Sydney esquire deceased of the one part and the Right Reverend Frederic Barker Doctor in Divinity Lord Bishop of Sydney and Metropolitan of the other part it was witnessed and it was thereby agreed and declared that the said Lord Bishop of Sydney and his successors should hold a debenture of five hundred pounds upon trust that the said Lord Bishop of Sydney and any of his successors should either permit the money represented by the said debenture to remain as the same was then invested or vary the said investment as he should think fit by investing the said money in the name of the Bishop of Sydney in real securities in New South Wales or in the Government Stock of New South Wales and should at his discretion do all acts necessary for that purpose and also should vary the said other investments as he should think fit and should pay the annual income of the said debenture or other securities by half-yearly payments to such one of the pupils of the King's School or

Institution being of not less than six months' standing in the said School or Institution as should under the regulations thereinafter mentioned be entitled to receive and enjoy the same and should continue to pay the same so long as such pupil should continue bona fide a pupil of the said King's School or Institution and it was thereby declared and agreed that if the said King's School or Institute should cease to exist or if for any other reason there should not be a pupil of the said King's School or Institute entitled under the regulations to receive and enjoy the said annual income of the said debenture or other securities then the said Bishop of Sydney for the time being should pay the said annual income by half-yearly payments to such pupil of any other school in New South Wales in connection with the United Church of England and Ireland as the said Bishop for the time being should select and who should comply with the regulations therein mentioned or with such other regulations as the Bishop of Sydney for the time being might in such case fix and determine and should continue to make such payment so long as the said pupil should continue bona fide a pupil of the said School AND WHEREAS the Schedule to the said Indenture set out the regulations as follows:-

- 1. The Examiners shall be the Bishop of Sydney the Dean of Sydney and the Archdeacon of Sydney for the time being or such other person or persons as the Bishop of Sydney may on occasion of any Examination appoint to act in place of himself or any other of the said Examiners.
 - 2. The subject of Examination shall be :--
 - 1. The Greek Testament.
 - 2 Such Greek and Latin Authors as the Examiners may select, notice of this selection to be given six months previously to the Examination.
 - 3. The Books of the Old and New Testament in English.
 - 4. The Church Catechism.
 - 5. Ancient and Modern History.
- 3. An Examination shall take place as soon as practicable after any vacancy in the scholarship shall have occurred and the successful candidate shall be entitled to the scholarship from the date of the occurring of such vacancy.

4. In case of equality between two candidates and one of them being the son of a Clergyman preference shall be given to such candidate.

AND WHEREAS by "The King's School Council Act" it was enacted that it should be lawful for the Bishop of Sydney for the time being by deed under the episcopal seal to assign and transfer the said "Broughton" Scholarship endowment funds as also the "Broughton and Forrest" and "Burton" hereinafter mentioned and any accumulations and investments thereof unto the Council of The King's School and thereupon the scholarship endowment funds, accoumulations and investments so assigned and transferred should become vested in the said Council and its successors as to each of such fund accumulations and investment's upon the Trusts and for the purposes declared by the instrument whereby the same was assigned to the said Bishop as hereinbefore recited and it should also be lawful for the Church of England Property Trust Diocese of Sydney by deed under its corporate seal to assign and transfer the "Macarthur" scholarship endowment fund and any accumulations and investments thereof unto the said Council and upon such assignment the said "Macarthur" scholarship endowment fund accumulations and investments should become vested in the said Council upon the trusts and for the purposes declared by the Indenture of the twenty-fourth day of June One thousand cight hundred and ninety-one hereinafter recited AND WHEREAS by Assignment unregistered bearing date the third day of August One thousand eight hundred and ninety-three the Most Reverend William Saumarez Smith Doctor of Divinity Lord Bishop of Sydney in pursuance of the powers vested in him for that purpose by the said Act did thereby assign and transfer unto the said Council and its successors all that the Broughton Scholarships Endowment Fund mentioned and comprised in the before recited Indenture and all accumulations and investments thereof to hold the same unto the said Council and its successors upon the trusts and for the purposes declared by the before recited, Indenture AND WHEREAS by the "Church of England Trust Property Act 1917" it was enacted that in that Act unless inconsistent with the context or subject matter "Church Trust Property" includes all or any part of any real and personal property which may for the time being be subject to any trust whether by

successors and assigns is hereinafter called the said Trustee of the third part it was thereby agreed and declared that the said Trustee should stand possessed of the sum of one thousand nine hundred pounds and the annual income and other accumulations thereof upon trust to invest the same in the stocks fund debenture or securities of the Governments of any of the Australasian Colonies or upon mortgage of freehold land in the Colony of New South Wales or upon deposit with any banking corporation carrying on business within the Colony of New South Wales with power from time to time to vary any investment or reinvest the said moneys or any part thereof upon or in any of the said hereinbefore authorised securities and to stand possessed of the interest or income arising from any such investment upon trust to provide thereout from time to time funds for scholarships to be awarded to boys who had been bona fide pupils for twelve months and upwards at The King's School at Parramatta or at any other place to which the said School might be removed who should be desirous of proceeding with their education at St. Paul's College Sydney with a view to taking Holy Orders in the Church of England and it was thereby agreed and declared that such scholarships should be awarded by the said Council to such persons as the Head Master for the time being of the said School should approve in such amounts not being less than the sum of thirty pounds to each of such boys and for such periods not exceeding four years and subject to such conditions rules and regulations as the said Council should from time to time direct appoint and determine in that behalf and it was thereby further agreed and declared that any portion of the said interest or income not required in any year for the purposes aforesaid should be invested in or upon any of the hereinbefore authorised securities and should form portion of the principal moneys subject to the trusts therein declared or at the discretion of the said Council might be applied at any future time either in augmentation of any scholarship then awarded or for any special purpose in furtherance of and consistent with the said trusts thereinbefore declared AND WHEREAS by Assignment third day of August bearing date the thousand eight hundred and ninety-three the Most Reverend William Saumarez Smith Doctor of Divinity Lord Bishop of Sydney in pursuance of the powers vested in him for that purpose by the hereinbefore recited King's School Council Act did thereby assign and transfer unto the said Council and its successors all Assignment that "The Burton Scholarship Endowment Fund" mentioned and comprised in the before recited Indenture and all accumulations and investments thereof to hold the same unto the said Council and its successors upon the trusts and for the nurposes declared by the before recited Indenture AND WHEREAS by "The King's School Council Act Amendment Act of 1894" it was enacted that the said Council should stand possessed of the endowment funds, accumulations and investments of the Burton Scholarship Certain upon trust to lay out the same upon some good and sufficient security of real property in New South Wales or upon Government debentures or Government stock and to apply the interest thereof towards affording a sound religious education in the principles of the Church of England at The King's School to one youth or more being a nupil or pupils of such school or desiring to onter as pupil or pupils or proceeding from the said school to passue his or their studies at Saint Paul's College within the University of Sydney as the Council might from time to time by resolution determine subject to the regulations of the Council and it was also enacted that the said Council should have nower from time to time to make and frame regulations for the purpose of carrying out the trusts of all or any of the scholarship funds then held or thereafter to be held in connection with the said school AND WHEREAS by Indenture of Assignment and Declaration of Trust bearing date the twenty-fourth day of June One thousand eight hundred and ninety-one unregistered and made between James Arthur Dowling and Edward Johnstone Jenkins joint honorary treasurers to the "Macarthur Macarthur Memorial Fund" as therein mentioned of the one part and the Church of England Property Trust Diocese of Sydney (hereinafter designated the said Trust) of the other part such Indenture reciting the following:-At a meeting of the General Committee of the said Fund held at 29 O'Connell Street Sydney on the fifteenth day of April One thousand eight hundred and ninety-one it was decided

That the funds referred to therein should be invested in or upon any of the public stocks debentures treasury bills public funds or Government securities of the Colony of New South Wales or other the Australian Colonies including New Zealand or of the United Kingdom of Great Britain or upon mortgages of freeholds or of leaseholds having not less than fifty years to run or upon deposit receipts at interest either for a fixed period or at call in any joint stock company carrying on business in any part of the places aforesaid or in or upon the stocks funds shares debentures debenture stocks mortgages or securities of any corporation company or public body municipal or otherwise (except mining companies) in any of the places aforesaid with full power from time to time to vary transpose or transfer such stocks funds shares securities and investments thereof into or for others of any nature hereby authorised.

- 3. That a scholarship amounting annually to the nett income of the trust fund be offered for competition.
 - 4. That it be an Entrance Scholarship.
 - 5. That it be awarded after a competitive examination.
 - 6. That in the examination allowance be made for age.
- 7. That the scholarship be open to boys between the ages of twelve and fifteen on the date of examination.
 - 8. That it be held by Boarders only at The King's School.
- 9. That The King's School Council appoint the Examiner or Examiners.
- 10. That the scholarship be granted for two years on satisfactory proof of diligence and good conduct and that it be renewable on the recommendation of the Head Master of The King's School.
- 11. That testimonials from candidates as to character and certificates of age must be supplied to the Head Master at least one week before the examination.
- 12. That the first examination be held on the first day of the third term near the end of July One thousand eight hundred and ninety-one and that the entrance thereon take effect immediately on the award being made.
- 13. That the emoluments from such scholarship shall be enjoyed only during residence at the school.

14. That a copy of these resolutions be forwarded to The King's School Council with the request that they will undertake to discharge the part assigned to them above And for the consideration therein mentioned the said James Arthur Dowling and Edward Johnstone Jenkins by the direction of the General Committee of the said fund did and each of them did assign transfer and set over unto the corporate trustees all that sum of four hundred and forty-eight pounds sixteen shillings and sixpence then standing to the credit of the "Macarthur Trust Fund" and any accumulation thereof or additions thereto upon trust to invest the same as thereinbefore mentioned and upon further trust to pay the annual nett income thereof by halfyearly payments to such pupils as should be certified in writing by the Council of The King's School or the Head Master thereof for the time being to be the Macarthur Scholar in the terms and according to the spirit of the aforesaid resolutions And it was thereby declared that if the said school should cease to exist the said Trust should hold the said sum of four hundred and fortyeight pounds sixteen shillings and sixpence and any accumulations thereof and additions thereto upon trust to pay the annual income thereof by equal half-yearly payments to such pupil of any other School in the said Colony in connection with the United Church of England and Ireland as the said Trust should select and should comply with all the said regulations as to examination hereinbefore mentioned AND WHEREAS by Indenture of Assignment of the third day of August One thousand eight hundred and ninety-three the said Trust in pursuance of The King's School Council Act did thereby assign and transfer unto "The Council of The King's School" and its successors all that "The Macarthur Scholarship Endowment Fund" hereinbefore mentioned and all accumulations and investments thereof to hold the same unto the said Council and its successors upon the trusts and for the purposes hereinbefore declared by the hereinbefore recited Indenture AND WHEREAS William Wentworth Bucknell established the "Wentworth Bucknell Scholarship" of £1000 at the said School in memory of his son Lieutenant Wentworth Bucknell who was killed fighting for his country the provisions Scholarship. of the said scholarship being as follows:-

1. The Scholarship to be open to any boarder who has been in residence at the School for at least two years.

- 2. To be awarded for a period of three years.
- 3. In the event of a holder leaving the said School before the expiration of the term of three years the Scholarship is to continue for the balance of his term provided that he enters the University of Sydney.
- 4. If the holder leaves the said School and does not enter the said University his Scholarship shall cease.
- 5. To be awarded to the sons of men and their descendants who served in the Great War commencing in One thousand nine hundred and fourteen if any boy is so available.
- 6. The examinations in connection with the Scholarship are to be prescribed by the said Council, but to be eligible therefor a boy must have taken an active and prominent part in the Cadet Corps and in Sports generally.
- 7. The income of the said one thousand pounds only to be paid to the holder.

Sydney See Scholarship, AND WHEREAS Lady Charlotte Hordern wife of Sir Samuel Hordern Ruby Meeks wife of John Oliver Meeks Lillie Anderson wife of William Aloysius Anderson John Charles Matthews See Henry Clarence Matthews See and Villiers James Grafton See established a Scholarship of one thousand pounds (£1000) at the said School in memory of their brother Sydney See who was killed fighting for his country the provisions of the said Scholarship being as follows:—

- 1. The name of the Scholarship to be the "Sydney See Scholarship."
- 2. The Scholarship to be available to a boy who has qualified by Matriculation Examination in Veterinary Science to enter the University.
- 3. If at the same time more than one boy has qualified it is to be left to the Dean of the Faculty of Veterinary Science to decide which of the candidates is the better qualified to hold the Scholarship.
- 4. The candidate selected to be entitled to at once receive fifty pounds (£50) (if funds then be available) to cover expenses already incurred or on account of the previous year's tuition as the case may be, and shall receive a further fifty pounds (£50)

at the end of the first and second years at the University subject to the said Council being furnished each year with a satisfactory certificate from the Dean of the Faculty of Veterinary Science as to the work and character of the holder of the Scholarship.

- 5. If at the end of his second year at the University no other suitable matriculant in Veterinary Science is available then on the recommendation of the Dean of the Faculty of Veterinary Science the previous candidate may receive the Scholarship for a third year.
- 6. The Dean of a Faculty of Veterinary Science shall decide whether the boy shall be required to enter one of the Colleges within the University during his tenure of the Scholarship.
- 7. Payment of the Scholarship at the said University to be made on the certificate of the Dean of the Faculty of Veterinary Science.
- 8. The income only of the said sum of one thousand pounds (£1000) to be paid to the holder.

AND WHEREAS Mary Futter established a Scholarship of one thousand pounds (£1000) in memory of John Dallas Futter the provisions of the said Scholarship being as follows:—

John Dallas Futter Scholarship.

- 1. The name of the Scholarship to be called "The John Dallas Futter Scholarship."
 - 2. To be open to Boarders at the School,
- 3. To be awarded by the Council on the recommendation of the Head Master.
- 4. To be awarded annually at the end of each year to a boy of seventeen years of age (or over) for the following year.
- 5. Equal consideration to be given to Scholastics and Sports not necessarily brilliancy or proficiency to be considered so much as the evidence of the real Public School spirit.
- 6. Other things being equal preference to be given to the son of an Old Boy and to the boy who will be of the greatest benefit to the School,
- 7. The income only of the said sum of One thousand pounds (£1000) to be paid to the holder.

Archdeacon Gunther Prize. AND WHEREAS the Venerable Archdeacon William James Günther established a prize of twenty-one pounds (£21) at the said School the conditions of the same being as follows:—

1. The income on the said sum of twenty-one pounds (£21) to be awarded annually to a pupil of the School in the form of books for proficiency in Greek Testament and History of the English Church.

Ellis A. Roth

AND WHEREAS Reuter Emerich Roth established a prize of one hundred pounds (£100) at the said School in memory of his son Ellis Roth the conditions of the same being as follows:

- 1. The interest on the said sum of one hundred pounds (£100) to be awarded annually to a pupil of the School in the form of books instruments etc. as a prize for mathematics.
 - 2. The Prize to be called the Ellis A. Roth Prize.

AND WHEREAS it is desirable to provide for pooling of the aforesaid Church Trust properties for the purpose of investment and for averaging the gains losses and interest and for the application of the income and also to validate such pooling and applications of income as have heretofore been effected or made by the said Council and their predecessors in office and to provide for the accumulation in the future of small surpluses of income for reserves and for additional Scholarships or benefits WHEREAS by reason of circumstances subsequent to the creation of the Trusts affecting the said Church Trust properties or some of them it has in the opinion of Synod (of the Diocese of Sydney) become impossible or inexpedient in some cases to carry out and observe in detail the trusts as originally established more particularly as regards the subjects of study or examination the nomination of examiners and other conditions under which such Scholarships or prizes were to be awarded and in other cases where the conditions of award of the Scholarship or benefit of any Trust or the regulations relating thereto are in the discretion of the Council the said Council for the better performance of such Trusts and in consideration of this Ordinance consenting thereto it is hereby declared and determined as follows:---

1. (a) The said Church Trust properties and the investments representing the same are hereby pooled for the purpose of invest-

ment of the capital assets funds and moneys thereof and from the date hereof the aggregate of the investments of the said Church Trust properties shall be treated as pooled upon this date and the income produced therefrom shall be attributable pro rata to the capital of the several trusts in the said pool and the gains losses interests outgoings and expenses of and incidental to such investment and pooling shall be averaged so that each Church Trust property represented in such pool shall receive or bear rateably according to its capital in the pool its due share of all such items of gain income loss or expenditure.

(b) All further sums or the produce of gifts received by the said Council for the purpose of prizes and/or scholarships shall be included in the aforesaid pooling.

- 2. All such pooling of the Church Trust properties hereinbefore mentioned as may have been effected by the said Council or have taken place under its management or the management of its predecessors and the applications of income arising therefrom are hereby validated.
- 3. The said Council shall from time to time invest the capital moneys in their hands of the said Church Trust properties and of any other Church Trust properties of which it shall obtain power and management under this Ordinance in the following securities namely—
 - (a) Any public funds or Government stock or Government securities of the Commonwealth of Australia or any State thereof or the Dominion of New Zealand or Fiji.
 - (b) Any debentures or securities guaranteed by the Government of New South Wales,
 - (c) Any debertures or securities issued by the Municipal Council of Sydney or any Municipal or Shire Council in New South Wales.
 - (d) Any public funds or parliamentary stocks or Government securities of the United Kingdom.
 - (e) Mortgage of land in New South Wales.
 - (f) Deposit in the Commonwealth Bank of Australia or in the Government Savings Bank of New South Wales.
 - (g) Any of the stocks funds or securities for the time being authorised for the investment of cash under the control

or subject to the order of the Supreme Court of New South Wales.

Provided that such investments shall in all respects be governed by the Trustee Act 1925 or any Act amending or taking the place of the same.

- 4. The Council shall not be bound to allocate as available for any scholarship prize or other annual purpose of any fund or endowment the full and exact income in the current or preceding year of such fund or endowment but may from time to time fix the annual amount of each such Scholarship or prize or benefit at such lesser sum as may be convenient and may add each year the unspent balances of any income not fully expended as aforesaid to the capital amount of the funds or endowments to which such unspent balances shall be respectively attributable to the end that further or more valuable scholarships prizes or benefits may be established by the Council from the same fund or endowment for the same general objects and in the same name and the Council may in its discretion instead of capitalising as aforesaid any unspent balance or the whole of it set the same or part thereof aside for a reserve in connection with the fund or endowment to which it pertains for the purpose of equalisation year by year of the amount of any scholarship prize or benefit arising from such fund or endowment. Provided that the annual amount of scholarships awarded under the Burton Scholarship Endowment Fund shall not be less than thirty pounds (£30) nor under the Sydney See Fund less than fifty pounds (£50) unless in the case of the said foundations or either of them their annual incomes shall be less respectively than the said annual sums.
- 5. In view of the alteration from time to time of the School curriculum and of the requirements or conditions of professional and other vocational examinations the Council may vary the subjects of examination and the examiners or the appointment of them and do such other things as may be in their opinion necessary to give proper effect to the various Trusts having regard to the objects and purposes of their foundation as shown in the recitals hereinbefore contained and all awards of Scholarships and prizes heretofore made by the said Council are vali-

dated notwithstanding that in some cases the conditions relating to the subjects or nature of examination or otherwise may have been only partially or otherwise imperfectly fulfilled.

- 6. In the event of any further Church Trust properties being given for the purposes of the said School the said Council may accept the same subject to the provisions of this Ordinance or any Ordinance amending or taking the place of this Ordinance.
- 7. This Ordinance may be styled and cited as "The King's School Scholarships Pooling and Investment Ordinance 1927."
