

# Maroubra (Sunman Estate) Variation of Trusts Ordinance 2019

No 33, 2019

## Long Title

An Ordinance to vary the trusts of a bequest from the late John Blyth Sunman for purposes in connection with the Parish of Maroubra.

## Preamble

A. By clauses 9(d) and 9(p)(ii) of the Will of John Blyth Sunman dated 18 August 2017 (the Sunman Will), the late John Blyth Sunman bequeathed a certain sum of money (the 'Sum') to St John's Maroubra Anglican Church. The Sum is to be applied, inter alia, "for the purpose of building the hall flats", with the wish that the flat be called 'Sunman Cottage' and provide accommodation for a "second senior pastor to take on the full time role in children and youth ministry" (the Sunman Cottage).

B. The wardens of the Parish (the 'Wardens') hold the Sum on trust for the purposes set out in the Will, including in respect of the Sunman Cottage.

C. By reason of circumstances which have arisen after the creation of the trusts on which the Sum is held, it is inexpedient to carry out and observe those trusts, and it is expedient that the trusts of the Sum be varied in the manner set out in this Ordinance.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

### 1. Name

This Ordinance is the Maroubra (Sunman Estate) Variation of Trusts Ordinance 2019.

### 2. Declarations

By reason of circumstances which have arisen after the creation of the trusts on which the Sum is held, it is inexpedient to carry out and observe those trusts, and it is expedient that the trusts of the Sum be varied in the manner set out in clause 3.

### 3. Variation of Trusts

The trusts of Sum (and any income accrued or earned on the investment of the Sum), in respect of the Sunman Cottage, are varied to the extent necessary so that it may be applied in and towards the costs of and incidental to housing a Minister, Assistant Minister or any person employed by the wardens of St John's Maroubra whose duties include ministry to children or youth, through –

- (a) the construction of a residence on existing land held on trust for the purposes of the Parish,
- (b) the purchase of land and the construction of a residence thereon, or
- (c) the purchase of land and residence and making any necessary alterations to the residence, or
- (d) purchase of a residence and making any alterations to the residence.
