

MEMBERSHIP OF COMMITTEES ORDINANCE 1975

No. 25, 1975

AN ORDINANCE to amend certain ordinances of Synod to establish that women may be appointed to serve on certain committees etc.

WHEREAS by resolution (No. 26/74) passed on 10 October 1974 the Synod requested the Standing Committee to examine the constituting ordinances of bodies under the control of Synod and if any doubt existed to amend those ordinances where appropriate to make the election of women possible NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

1. (1) This Ordinance may be cited as "Membership of Committees Ordinance 1975".

(2) The Moore College Ordinance of 1919 as amended and as further amended by this Ordinance may be cited as "Moore College Ordinance, 1919-1975".

(3) The Sydney Diocesan Educational and Book Society Ordinance 1918 as amended by this Ordinance may be cited as "Sydney Diocesan Educational and Book Society Ordinance 1918-1975".

(4) The Sydney Church of England Investment Trust Constitution Ordinance 1965-1974 as amended by this Ordinance may be cited as "Sydney Church of England Investment Trust Constitution Ordinance 1965-1975".

(5) The Car Finance Board Ordinance 1952-1970 as amended by this Ordinance may be cited as "Car Finance Board Ordinance 1952-1975".

(6) The Sydney Church of England Finance and Loans Board Ordinance 1957-1970 as amended by this Ordinance may be cited as "Sydney Church of England Finance and Loans Board Ordinance 1957-1975".

2. The Moore College Ordinance of 1919 as amended is hereby further amended by the deletion of the words "Laymen" and "Layman" where appearing from clause 3 (d) and (e) and in each case by inserting in lieu thereof the words "Lay Persons" or "Lay Person" as the case may be.

3. The Rules of the Sydney Diocesan Committee and Educational and Book Society as adopted and amended by The Sydney Diocesan Educational and Book Society Ordinance 1918 are hereby amended by the deletion of the word "Laymen" where appearing in Rule 4 and by inserting in lieu thereof the words "Lay Persons".

4. The Sydney Church of England Investment Trust Constitution Ordinance 1965-1974 is hereby amended by the deletion of the word "Laymen" from clause 2 (i) and by inserting in lieu thereof the words "Lay Persons".

5. The Car Finance Board Ordinance 1952-1970 is hereby amended by the deletion of the word "laymen" from clause 2 (ii) and by inserting in lieu thereof the words "lay persons".

6. The Sydney Church of England Finance and Loans Board Ordinance 1957-1970 is hereby amended by the deletion of the word "Laymen" where appearing in clauses 3 (b) and 6 and by inserting in lieu thereof the words "Lay Persons".
