No 32. 1989

AN ORDINANCE to carry out certain law reforms

WHEREAS it is expedient to clarify and update the terminology of certain ordinances.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES

Accounts Ordinance

- 1. The First Schedule of the Accounts Ordinance 1975 is amended -
 - (a) by omitting the words "14. New Sites Advisory Committee"; and
 - (b) by renumbering items 15 to 22 as 14 to 21 respectively.

Anglican Youth Department Ordinance 1985

- The Anglican Youth Department Ordinance 1985 is amended
 - a) by omitting "layman" from clause 4 and inserting instead "layperson";
 - (b) by omitting from paragraph (c) of subclause (1) of clause 5 the words "Board of Education of the" and inserting instead "Board of Education: ":
 - (c) by omitting the first sentence of subclause (2) of clause 5;
 - (d) by omitting the last sentence of subclause (3) of clause 5;
 - (e) by omitting from clause 9 the words "provisional district" and by inserting instead "assisted provisional parish";
 - (f) by omitting from clause 10 the words "Church of England" where first appearing and by inserting "Anglican Church"; and
 - (g) by inserting in clause 11 after the figures "1975" the words "and the Investment of Church Trust Property Ordinance 1978".

Sydney Anglican None Mission Society Ordinance 1981

- 3. The Sydney Anylican Home Mission Society Ordinance 1981 is amended
 - (a) by omitting subclauses (3) and (4) of clause 3;
 - (b) by omitting from clause 4 the words "Church of England in" and by Linserting instead "Anglican Church of";
 - (c) by omitting the second sentence of clause 6;
 - (d) by omitting from clause 7 the words "as amended from time to time";
 - (e) by omitting clause 8;

MISCELLAMEOUS AMENDMENTS ORDINANCE 1989

- (f) by omitting from clause 14 the words "as amended from time to time";
- (g) by omitting from subclause (2) of clause 15 the words "Church of England" where appearing and by inserting instead "Anglican Church of Australia" in each place; and
- (h) by omitting from clause 16 the words "and present income and expenditure accounts and a balance sheet duly audited".

Interpretation Ordinance 1985

- 4. The Interpretation Ordinance 1985 is amended
 - (a) by omitting from clause 5(a) the matter ", 1897" and by inserting instead the matter "1987"; and
 - (b) by inserting the following new clause after clause 9 -
 - \$10. Where a reference in an Act or ordinance is (by or under any Act or ordinance) to be read or construed as; or taken to be or deemed to be, or otherwise treated as, a reference to
 - (a) an act, patter, person or thing; or
 - (b) an act, matter, person or thing by a particular description or title;

the Diocesan Secretary may in reprinting an ordinance in which the firstmentioned reference occurs make such amendments to the ordinance as

- (c) will result in the omission from the ordinance of the firstmentioned reference and, unless inappropriate, the substitution therefor of the secondmentioned reference; and
- (d) are incidental to or consequential on the omission or substitution or both."

Area Deanery Conference Ordinance 1965

- 5. Subclause (1) of clause 2 of the Area Deanery Conference Ordinance 1965 is amended -
 - (a) by omitting from paragraph (b) the words "and resident ministers licensed to assisted provisional parishes within the area deanery";
 - (b) by comitting from paragraph (g) the words "Church of England Constitutions Act Amendment Act of" and by inserting instead "Anglican Church of Australia Constitution Act";
 - (c) by omitting from paragraph (i) the words "Church of England in" and by inserting instead "Anglican Church of";

(d) by omitting from paragraph (j) the words "Church of England in" and by inserting instead "Anglican Church of".

Citation

6. This Ordinance may be cited as the "Miscellaneous Amendments Ordinance 1989".
