Miscellaneous Amendments Ordinance 1992

No 37, 1992

An ordinance to carry out certain law reforms.

Whereas it is expedient to amend certain ordinances.

Now the Synod of the Diocese of Sydney Hereby Ordains Declares Directs and Rules as follows -

Citation

1. This Ordinance may be cited as the "Miscellaneous Amendments Ordinance 1992".

Accounts Ordinance 1975

- 2. The Accounts Ordinance 1975 is amended -
 - (a) by relettering paragraph (i) of clause 8 as paragraph (i).
 - (b) by relettering as paragraph (i) that paragraph of clause 8 lettered (h) which is in the following terms -

"Whether a satisfactory system of Internal Control has been maintained."

- (c) by deleting the following from the First Schedule -
 - "1. Anglican Counselling Centre"
 - *10. Historic Buildings Preservation Council*

and renumbering the remaining paragraphs of the First Schedule consequent upon the foregoing deletions.

- (d) by inserting the following into the Second Schedule after paragraph 1.
 - "2. Anglican Counselling Centre"

and renumbering the remaining paragraphs of the Second Schedule consequent on the foregoing insertion.

Long Service Leave Ordinance 1973

- The Long Service Leave Ordinance 1973 is amended
 - (a) by deleting the matter "-1973" and "-1967" in each of the long title and the preamble;
 - (b) by deleting the matter "-1967" in each of clauses 1(1)(a) and 1(1)(b);
 - by deleting the words "provisional district" in clause 1(1)(e) and by inserting instead the words "assisted provisional parish";
 - (d) by inserting the word "leave" after the words "long service" in clause 15(2)(b);
 - (e) by deleting from the Schedule "Tara Church of England Girls' School" and Ly inserting instead "Tara Anglican Girls' School";
 - by inserting the names of the following organisations in the Schedule -

Council of Macarthur Region Anglican Church School

Campbelltown Anglican Schools Council St Andrew's Cathedral School Council,

(g) by inserting the name of the following organisation in the Schedule -

William Branwhite Clarke College Council.

- 4. (1) The amendments made to the Long Service Leave Ordinance 1973 by clauses 3(f) and 3(g) are deemed to have effect on and from -
 - (a) in the case of clause 3(f), 8 April 1992; and
 - (b) In the case of clause 3(g), 12 August 1992.
- (2) The amendments made by clauses 3(f) and 3(g) do not have effect in relation to the employment of a person with an organisation referred to in those clauses if the employment commenced prior to the date referred to in clause 4(1) applicable to that organisation.

Synod Representative and Membership Ordinance 1945

- 5. The Synod Representative and Membership Ordinance 1945 is amended by deleting clause 1(4).
