

Miscellaneous Amendments Ordinance 1996

No 30, 1996

An Ordinance to carry out certain law reforms.

The Synod of Diocese of Sydney Ordains -

Name

1. This Ordinance is the Miscellaneous Amendments Ordinance 1996.

Amendment of the Parishes Ordinance 1979

- 2. Clause 4 of the Parishes Ordinance 1979 is amended -
- (a) by omitting from subclause (4) the matter "(b), (c)" and by inserting the matter "(aa), (b), (c), (ca)," instead; and
- (b) by omitting paragraph (c) of subclause (8A) and inserting instead -
- "(c) paragraph (ca) of subclause (1) of this clause to change a provisional parish to an assisted provisional parish; and
- (d) paragraph (d) of subclause (1) of this clause to revoke an assisted provisional parish, to the Executive Director of the Home Mission Society. The Home Mission Society shall send to the Archbishop a written report as to the reasons for or against the proposal. Any such report received after 3 months of the date on which a copy of the proposal is sent to the Executive Director may be disregarded and shall not prevent effect being given under this ordinance to any proposal."

Amendment of the Presentation and Exchange Ordinance 1988

- 3. The Presentation and Exchange Ordinance 1988 is amended -
- (a) by omitting from paragraph (c) of subclause 13(1) the word "Area" and inserting the word "Regional" instead; and
- (b) by omitting from clause 41 the matter "assistant bishops for the time being exercising episcopal duties over areas within the Diocese" and inserting the words "Regional Bishops" instead.

Conferral of Rights

- 4. A right conferred by an ordinance (the "Principal Ordinance") -
- (a) on "PARC" or the "Parramatta Anglican Regional Council" is taken to be conferred on the Parramatta Regional Council constituted under the Regions Ordinance 1995;
- (b) on "WARC" or the "Wollongong Anglican Regional Council" is taken to be conferred on the Wollongong Regional Council constituted under the Regions Ordinance 1995;

- (c) on "ICCOM" or the "Inner City Committee" is taken to be conferred on the South Sydney Regional Council constituted under the Regions Ordinance 1995; and
- (d) on "MADCOM" or the "Marrickville Area Deanery Committee" is taken to be conferred on the Georges River Regional Council constituted under the Regions Ordinance 1995,
