

#### **Miscellaneous Amendments Ordinance 1999**

No 27, 1999

## **Long Title**

An Ordinance to amend various ordinances.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows -

#### 1. Name

This Ordinance is the Miscellaneous Amendments Ordinance 1999.

#### 2. Accounts, Audits and Annual Reports Ordinance 1995

The Accounts, Audits and Annual Reports Ordinance 1995 is amended as follows -

(a) in clause 17 the definition of "Parish" is deleted and the following is inserted instead -

"Parish' means a parish or provisional parish in the Diocese constituted or recognised under the Parishes Ordinance 1979, and includes parish councils and churchwardens.";

- (b) in the First Schedule -
- (i) the names of the following organisations are deleted -

Anglican Youth Department Diocese of Sydney

Inner City Committee

Marrickville Area Deanery Committee

Parramatta Anglican Regional Council

Wollongong Anglican Regional Council; and

(ii) the names of the following organisations are inserted in the appropriate alphabetic order -

Georges River Regional Council

North Sydney Regional Council

South Sydney Regional Council

Western Sydney Regional Council

Wollongong Regional Council; and

- (c) in the Second Schedule -
- (i) the name "Anglican Education Commission Diocese of Sydney" is deleted; and
- (ii) the name "Anglican Youth & Education Division Diocese of Sydney" is inserted in the appropriate alphabetic order.

#### 3. Annual Leave Ordinance 1983

The Annual Leave Ordinance 1983 is amended as follows -

- (a) in the definition of "churchwardens" in clause 1(2) the matter "parish, provisional parish or assisted provisional parish" is deleted and the matter "parish or provisional parish" is inserted instead;
- (b) in the definition of "ecclesiastical district" in clause 1(2) the matter ", assisted provisional parish" is deleted;
- (c) in clause 1(2), paragraph (c) of the definition of "minister" is deleted; and
- (d) in clause 4(b) the matter "or with the Sydney Anglican Home Mission Society in the case of an assisted provisional parish" is deleted.

#### 4. Archbishop of Sydney Appointment Ordinance 1982

Clause 15(1) of the Archbishop of Sydney Appointment Ordinance 1982 is amended as follows -

- (a) the matter "(a)" is deleted; and
- (b) the matter "11" is deleted and the matter "11(1)" is inserted instead.

## 5. Area Deanery Conference Ordinance 1965

The Area Deanery Conference Ordinance 1965 is amended as follows -

- (a) in clause 1(2) the matter "parishes, provisional parishes and assisted provisional parishes" is deleted and the matter "parishes and provisional parishes" is inserted instead;
- (b) clause 2(1)(g) is deleted and the following is inserted instead -
- "(g) Synod members summoned under Parts 5, 6, 7, 8 and 9 of the Synod Membership Ordinance 1995 who are resident within the area deanery,";
- (c) in clause 2(1)(h) the matter "parishes, provisional parishes, and assisted provisional parishes" is deleted and the matter "parishes and provisional parishes" is inserted instead;
- (d) in clause 2(1)(i) the matter "parish, provisional parish or assisted provisional parish" is deleted and the matter "parish or provisional parish" is inserted instead; and
- (e) in clause 3 the matter "Standing Orders of the Synod" is deleted and the matter "The rules of procedure of the Synod (by whatever name called)" is inserted instead.

## 6. Assessment and Charges Ordinance 1975

The Assessment and Charges Ordinance 1975 is amended as follows -

- (a) in paragraph (vi) of the proviso to clause 3 the matter "Permanent Conservation Orders" is deleted and the matter "listing on the State Heritage Register" is inserted instead; and
- (b) in paragraph (vii) of the proviso to clause 3 the matter "the Inner City Committee," is deleted.

## 7. Assistant Bishops (Bishops Coadjutor) Ordinance 1947

The Assistant Bishops (Bishops Coadjutor) Ordinance 1947 is amended as follows -

- (a) in clause 6(2) the matter "Sydney Diocesan" is deleted; and
- (b) in clause 9 the matter "-1981" is deleted.

#### 8. Church Administration Ordinance 1990

The Church Administration Ordinance 1990 is amended as follows -

- (a) in clause 11(1)(n) the matter "Sydney Representative and Membership Ordinance 1945" is deleted and the matter "Synod Membership Ordinance 1995" is inserted instead;
- (b) in clause 12(1)(p) the matter "Synod Representative and Membership Ordinance 1945" is deleted and the matter "Synod Membership Ordinance 1995" is inserted instead;
- (c) in clauses 20(1)(k)(ix) and 20(1)(l)(ii) the matter "Accounts Ordinance 1975" is deleted and the matter "Accounts, Audits and Annual Reports Ordinance 1995" is inserted instead.
- (d) in clause 23(1) the matter "11(l), 12(i)" is deleted and the matter "11(1)(l), 12(1)(i)" is inserted instead; and
- (e) in clause 23(3) the matter "11(h) or 12(h)" is deleted and the matter "11(1)(h) or 12(1)(h)" is inserted instead.

#### 9. Church Grounds and Buildings Ordinance 1990

In clause 12(2) of the Church Grounds and Buildings Ordinance the matter ", a parish council" is deleted.

## 10. Deaconesses, Readers and Other Lay Persons Ordinance 1981

In clause 1(1) of the Deaconesses, Readers and Other Lay Persons Ordinance 1981 the definition of "church committee" is deleted.

### 11. Extra-Parochial Ordinance 1918

In clause 5 of the Extra-Parochial Ordinance 1918 the matter "-1949" is deleted.

#### 12. Parishes Ordinance 1979

The Parishes Ordinance 1979 is amended as follows -

- (a) clause 1(1)(j) is deleted; and
- (b) in clause 4(4) the matter "(aa)," and ", (ca)" is deleted.

### 13. Presentation and Exchange Ordinance 1998

The Presentation and Exchange Ordinance 1988 is amended as follows -

- (a) clause 8(b)(i) is deleted and the following is inserted instead -
- "(i) for assessments and charges under the Assessments and Charges Ordinance 1975; and";
- (b) clause 15(b)(i) is deleted and the following is inserted instead -
- "(i) for assessments and charges under the Assessments and Charges Ordinance 1975; and".

#### 14. Regions Ordinance 1995

The Regions Ordinance 1995 is amended as follows -

- (a) in the definition of "parochial unit" in clause 2(1) the matter ", assisted provisional parish" is deleted;
- (b) clause 7(a) is deleted and the following matter is inserted instead -

- "(a) the Assessment and Charges Ordinance 1975;";
- (c) clause 7(d) is deleted and the following matter is inserted instead -
- "(d) the Ordinance Procedure Ordinance 1973;"; and
- (d) in clause 9(1) the matter "Accounts Ordinance 1975" is deleted and the matter "Accounts, Audits and Annual Reports Ordinance 1995" is inserted instead.
