

# Miscellaneous Amendments Ordinance 2024

No 14, 2024

## Long Title

An Ordinance to make a number of miscellaneous amendments to ordinances of the Anglican Church in the Diocese of Sydney.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

### 1. Name of ordinance

This Ordinance is the Miscellaneous Amendments Ordinance 2024.

### 2. Amendment of the Reportable Allegations and Convictions Ordinance 2022

The *Reportable Allegations and Convictions Ordinance 2022* is amended as follows –

- (a) in subclause 2(1), in the definition of ‘Children’s Guardian’, delete the matter “period” and insert instead the matter “person”, and
- (b) in subclause 4(2), before the matter “unconditional”, delete the matter “a”, and insert instead the matter “an”, and
- (c) in subclause 6(b) –
  - (i) after the matter “WWCC Employee”, insert the matter “,”, and,
  - (ii) after the matter “the allegation”, insert the matter “,”, and
- (d) in subsection 6(e) –
  - (i) after the first matter of “WWCC Employee”, insert the matter “,”, and,
  - (ii) after the matter “reportable allegation”, insert the matter “,”.

### 3. Amendment to the Ministry Standards Ordinance 2017

The *Ministry Standards Ordinance 2017* is amended as follows –

- (a) in the ‘Features of the Complaints Process’ table –
  - (i) in the second column on the row with the question “*What form of investigation will be taken?*”, delete the matter “progress”, and insert instead the matter “progresses”, and
  - (ii) in the second column on the row with the question “*How long does the process take from start to finish?*”, after the matter “reach a final outcome”, insert the matter “.”, and
  - (iii) in the third column on the row with the question “*Are the outcomes confidential?*”, delete the matter “PSU”, and insert instead the matter “Office of the Director of Safe Ministry”, and
- (b) in subclause 4(1) –
  - (i) in the definition of “child-related work”, delete the matter “(NSW)”, and
  - (ii) in the definition of “disqualifying offence”, italicise the matter “Child Protection (Working with Children) Act 2012”, and
  - (iii) following the definition of “under legal incapacity”, delete the matter “(NSW)”, and
- (c) in subclause 6(2)(a), delete the first superscript “1” after the matter “from time to time,”, and
- (d) in subclause 6(2)(h), delete the matter “(NSW)”, and
- (e) in subclause 6(2)(n), delete the matter “(NSW)”, and
- (f) in subclause 12(1), at the end of the subclause, delete the second full-stop.

### 4. Amendment of the Ministry Infrastructure Development Fund Ordinance 2022

The *Ministry Infrastructure Development Fund Ordinance 2022* is amended as follows –

- (a) by deleting the following matter in the table in the Schedule –

Cnr Hunter & Emmett Street, Callala Bay	Lot 1271 in Deposited Plan 836301

- (b) by inserting the following matter in the table in the Schedule after the final row –

10 Summit Place, Leppington	Lot 8 in Deposited Plan 1275644
