Miscellaneous Amendments Ordinance (No 1) 1991

No 37, 1991

An Ordinance to carry out certain law reforms.

Whereas it is expedient to clarify and update the terminology of certain ordinances.

Now the Synod of the Diocese of Sydney ordains as follows -

Accounts Ordinance 1975

- The Accounts Ordinance 1975 is amended
 - (a) by repealing clause 3;
 - (b) by inserting the words "Certified Practising" in clause 6(1) after the words "Australian Society of";
 - (c) by omitting item "3. Anglican Provident Fund (Sydney)" from the First Schedule and by inserting that item in the Second Schedule as item 2:
 - (d) by inserting a new item "8. Continuing Education for Ministers" in the First Schedule after item 7; and
 - (e) by renumbering the items in the First and Second Schedules consequent upon the foregoing changes.

Assessment Authorisation Ordinance 1975

2. Para raph 4 (c) of the Assessment Authorisation Ordinance 1975 is repealed.

Church Insurances Ordinance 1981

3. Clauses 7, 8 and 9 of the Church insurances Ordinance 1981 are repealed without affecting the amendments made by clause 8 to the Anglican Church Property Trust Diocese of Sydney Ordinance 1965.

Deaconesses, Readers and Other Lay Persons Ordinance

4. Clause 14 of the Deaconesses, Readers and Other Lay Persons Ordinances 1981 is repealed.

Delegation of Powers and Ordinance Procedure Ordinance 1973

- 5. The Delegation of Powers and Ordinance Procedure Ordinance 1973 is amended
 - (a) by omitting from paragraph 15(b) the words "five thousand dollars (\$5,000)" and by inserting instead the words "\$15,000 or other limit set by the Standing Committee from time to time";
 - (b) by omitting from clause 19 the words "Bishop in Parrametta" and by inserting instead the words "Bishop of Parrametta"; and
 - (c) by omitting from clause 20 the words "Bishop in Wollongong" and by Inserting instead the words "Bishop of Wollongong".

Interpretation Ordinance 1985

- 6. The Interpretation Ordinance 1985 is amended -
 - (a) by inserting the following sentence at the end of clause 8 -"The clause headings and the table of provisions of an ordinance are not part of the text of that ordinance."; and
 - (b) by inserting the following new clause after clause 10 -
 - "11. A reference in an ordinance to an ordinance which has been repealed may be construed as a reference to which clause 10 applies and may be amended in accordance with clause 10."

Parishes Ordinance 1979

- 7. The Parishes Ordinance 1979 is amended -
 - (a) by omitting from clause 1(2) the words "Bishop in Parramatta" wherever occurring and by inserting instead the words "Bishop of Parramatta";
 - (b) by omitting from clause 1(3) the words "Bishop in Wollongong" wherever occurring and by inserting instead the words "Bishop of Wollongong";
 - (c) by omitting from clause 2(2) the words "except insofar as it relates to new housing districts and to the formation of a new housing district";
 - (d) by repealing clause 3:
 - (e) by omitting paragraph 6(b) and by inserting instead the following paragraph --
 - "(b) all assessments payable by the ecclesiastical district pursuant to an ordinance or ordinances made by the Synod have been or will be paid."; and
 - (f) by omitting from clause 6 the words "provisional parish" wherever occurring and by inserting instead the words "ecclesiastical district".

Presentation and Exchange Ordinance 1988

8. Subclauses 46(2) and (3) and clause 48 of the Presentation and Exchange Ordinance 1988 are repealed but without affecting the past operation of those clauses.

Standing Committee Ordinance 1897

9. The two provisos to clause 1(2) of the Standing Committee Ordinance 1897 are repealed but without affecting the past operation of those provisos.

Synod Representative and Membership Ordinance 1945

10. Subclauses 1(2) and (3) of the Synod Representative and Membership Ordinance 1945 are repealed but without affecting the past operation of those subclauses.

- 11. This Ordinance may be cited as the "Miscellaneous Amendments Ordinance (No 1) 1991".
