AN ORDINANCE to authorise the mortgaging of certain lands held in trust for Moore Theological College at Newtown and for purposes connected therewith—

## WHEREAS-

- A. Certain lands short particulars whereof are set forth in the Schedule hereto are held in trust for the use and benefit and purposes of the Institution known as Moore Theological College at Newtown (hereinafter called "the College").
- B. By reason of the increase in the number of the students of the College it recently became necessary to make large additions and alterations to the College Buildings and to borrow money for that purpose.
- C. For the purpose of securing the moneys already borrowed and further moneys intended to be borrowed it has become expedient to mortgage some or all of the said lands.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod Ordains Directs and Declares as follows:—

- 1. By reason of circumstances subsequent to the creation of the trusts to which the said lands are subject it is expedient to mortgage the same excluding therefrom the land upon which the Chapel is erected.
- 2. The said lands or any part thereof may be mortgaged from time to time in such manner and to secure the repayment of such amount not exceeding Twenty thousand pounds as the Trustees of the College shall from time to time determine and accordingly such mortgaging is hereby directed.
  - 3. The moneys so secured shall be applied as follows:-
  - (a) In repaying all moneys borrowed as aforesaid.
  - (b) In paying for the said additions and alterations
  - (c) In paying for the furnishing of the said additions.

- (d) In redeeming any prior mortgage given in pursuance of this Ordinance.
- (e) In paying all costs charges and expenses of and incidental to the foregoing.
- 4. This Ordinance may be cited as "The Moore Theological College Mortgaging Ordinance 1952."
